Purpose:

To draft and scrutinise fiscal and intergovernmental legislation and manage the legislative process pertaining to applicable legislation.

Requirements:

- LLB or equivalent Degree.
- 8-10 years' experience obtained in a legal environment;
- Extensive experience of constitutional and administrative law and interpretation of statutes;
- Extensive legislative drafting experience;
- Experience in the parliamentary processes for the passing of legislation.
- Understanding of intergovernmental relations, the budget process, and public finance

Key Outputs:

- Provide guidance to the National Treasury in respect of legislative processes and participate in policy processes requiring reflection or entrenchment in legislation.
- Scrutinise draft Bills, prepared elsewhere, on technical quality, adherence to best practice and consistency with the Constitution and other primary legislation.
- Draft Bills where drafting capacity does not exist elsewhere.
- Assist in the costing or regulatory impact assessment of draft legislation.
- Prepare and submit documentation required for the submission of Bills to Cabinet and Parliament.
- Oversee and facilitate all aspects of the Parliamentary legislative process and legal instruments associated with the promulgation and commencement of legislation.
- Comment on draft fiscal and intergovernmental legislation.
- Co-ordinate comments and inputs on draft Bills initiated by other national departments submitted to the National Treasury before Cabinet processes.
- Scrutinise draft legislation submitted to Cabinet Committees or Cabinet to prepare the Minister of Finance's input on the legislation, by highlighting provisions that may-impact on the National Treasury, legislation administered by the National Treasury or the National Revenue Fund, impact the financial interests of the provincial and local spheres of government; and only be introduced by the Minister of Finance or with the Minister's approval.
- Prepare regulations where drafting capacity does not exist elsewhere.
- Prepare documentation required for the promulgation of regulations.
- Scrutinise regulations requiring the Minister of Finance's concurrence to prepare inputs.
- Co-ordinate comments and inputs on draft regulations initiated by other national departments submitted to the National Treasury before promulgation.
- Audit legislation for technical quality, adherence to best practice and other primary legislation of the National Treasury.

- Assess legislative requirements against government's policy objectives.
- Initiate reviews of legislation.
- Furnish written or oral advice on legislative matters pertaining to existing fiscal or intergovernmental related legislation.
