Minimum of 4 years' experience in development sector with planning, budgeting and financial management skills • An understanding of budgeting, financial management and analysis, economic and fiscal policy as well as Government budget processes • Detailed knowledge of the social development sector • Strong policy research and analysis skills • Knowledge of the PFMA and Division of Revenue Act (DORA) • Ability to analyse complex information and large datasets and summarise findings/recommendations • Problem-solving, planning, and organising skills • Strong verbal and written communication skills • Ability to work independently.
