MANGAUNG INTERVENTION IN TERMS OF SECTION 139 (5) (a) & (c)

The Deputy Minister of Finance, Dr. David Masondo, today conducted an oversight visit to the Free State Province to engage with the provincial executive on the recently initiated intervention in the Mangaung Metropolitan Municipality. Deputy Minister Masondo was accompanied by Cooperative Governance and Traditional Affairs (COGTA) Deputy Minister Mr. Parks Tau.

Mangaung Municipality's finances have deteriorated substantially since 2018/19, leading to the adoption of a financial recovery plan for the municipal council, as jointly agreed between the national department of COGTA and National Treasury. Nevertheless, poor governance and budget management in the municipality, as well as low revenue collection, led to the ineffectiveness of the financial recovery plan and a cash-flow crisis during the 2019/20 financial year.

Deputy Minister Masondo wrote to the provincial executive of the Free State Province on 11 December 2019, recommending that an intervention in terms of Section 139 (5) of the Constitution, be implemented in Mangaung Metro. Subsequent to this, the Free State provincial executive council (EXCO) resolved on 19 December 2019 to invoke Section 139 (5) (a) and (c) of the Constitution, and to appoint an Intervention Team composed of provincial and national government officials, to assist with the development and implementation of a mandatory Financial Recovery Plan in the metro.

During his visit on 11 February 2020, Deputy Minister Masondo highlighted the current economic and fiscal situation in the country, and the implications of this for the finances of the province and local government. In this regard, he emphasized the need to drastically improve efficiency of spending, address governance failures, and eliminate waste and corruption. In addition, National Treasury officials presented a draft financial recovery plan to the Provincial exco, and the Mayoral Committee of Mangaung Municipality. Deputy Minister Tau and officials from COGTA also discussed a plan to address service delivery and governance failures.



ADDITIONAL INFORMATION

Section 139 (5) (a) and (c) makes provision for an intervention in a municipality by a province, without dissolving the municipal council. In this regard, while the council is not dissolved, it is obligated in terms of this section of the Constitution to implement the financial recovery plan which has been jointly drafted by the National Treasury and the Provincial Treasury.

The financial recovery plan will be divided into 3 phases. The initial phase is designed to bring swift recovery in the operations of the municipality. In addition to the Financial Plan, a service delivery recovery plan has been drafted and will be implemented under the supervision of the national and provincial departments of cooperative governance. A set of draft indicators have been proposed by National Treasury and COGTA within the recovery plans. Pending the approval of the province, these indicators will be used to monitor progress, and the Intervention Team will report monthly to the province, the National Treasury and national COGTA.
