## NOTICE TO BIDDERS: TABLE 2 OF THE SPECIAL CONDITIONS OF CONTRACT

<b>Bid No</b>	RT8-2024
<b>Bid Description</b>	Transportation of Cargo and Furniture Relocation Services for the State for the Period of 36 Months

Kindly note that clause 5.1.5 has been added under table 2 on page 9 of 29 of the Special Conditions of Contract to provide further clarity to bidders :

5.1.5 A list was established of all the services required by the end users as detailed below:

**i. Furniture/Office Removal;**

This service relates to the transportation of furniture. This service includes the removal and storage of office furniture to other destinations within South Africa.

**ii. Road Freight;**

Road freight refers to road haulage or road transport. It is often the most effective mode of transport. This service also includes transportation of vehicles.

**iii. Sensitive Cargo;**

These are articles or substances that may pose a risk to humans or the environment. Transportation of sensitive cargo e.g., explosive, flammable, corrosive, noxious, poisonous, radioactive, and irritative substances, commodities that emit poisonous vapor and are dangerous when wet, bio-medical material, substances liable to spontaneous combustion, pressurized gases, and magnetized metal.

**iv. Storage Fees;**

The storage at an intermediate point of goods that are to be reshipped to their final destination within a prescribed period.

**v. Handling Fee (Dismantling and Reassembling);**

This service ensures that the furniture is safely dismantled without damaging it and reassembled upon arrival. This is done to ensure that goods are delivered in the same quality that the user has requested.

**vi. Packaging Fee;**

Labour cost incurred for furniture removal i.e., wrapping and packaging of furniture.



**vii. Shuttle Services;**

Service used by main hauling trucks where there are restrictions. These can include height or weight restrictions at the existing or new premises which means the truck has to be park further away. A smaller vehicle is needed to move goods from the truck to the entrance of the premises.

**viii. Forklift.**

A forklift (also called lift truck, jitney, fork truck, fork hoist, and forklift truck) is a power industrial truck used to lift and move materials over a short distance.

**ix. Vehicle Transportation**
