##### 1. *Background to the tender:*

1.1 Sustainability, bycatches and discarding practices in fisheries have become highly publicised, contentious issues in the international conservation arena, Marine & Coastal Management (M & CM), of the Department of Environmental Affairs & Tourism wishes to ensure that South Africa's Offshore Fish Resources are sustainably harvested and that South African Vessels Fishing in domestic waters and on the high seas, operate in accordance with internationally accepted conservation principles (e.g. the Agreement for the Implementation of the Provisions of the United Nations Convention on the Law of the Sea, 1982, relating to the Conservation and Management of Straddling Stocks and Highly Migratory Fish Stocks, 1995; the Agreement to Promote Compliance with International Conservation and Management Measures by Fishing Vessels on the High Seas, 1993; the Code of Conduct for Responsible Fishing, 1995).

1.2 The use of observers for gathering scientific data relating to fish biology, catches and fishing activities has gained rapid international recognition and acceptance, Shipboard observers have been used, to varying extents, in several South Africa offshore fisheries over the last several years. These pilot observer programmes have yielded information that has been of considerable value to scientists, resource managers and users alike, and M & CM has taken the decision to adopt scientific observer programmes as an integral component of its resource management strategy.

1.3 M & CM wishes to structure all observer deployment through the establishment of a formalised shipboard observer programme. To this end, the provision of observer services is to be procured through a tender process.

*2. The tender:*

2.1 To supply and deploy trained, scientific shipboard observers aboard specified fishing fleets for the purpose of collecting scientific information (catch and effort data; biological data), as well as compliance-related information, to be used toward improved utilisation and management of offshore fishery resources.

2.2 To collate and submit the data and information collected by observers to Marine & Coastal Management (M & CM) as specified.

2.3 To facilitate the deployment of M & CM compliance personnel aboard fishing vessels, as and when requested.

*3. The pre-tender meeting:*

3.1 M & CM calls upon all interested parties to attend a pre-tender meeting during which the draft tender document will be discussed. The aim of the meeting is to revise the document, where necessary, in order to facilitate a smooth tender process.
