#### SPECIAL DIRECTION FINDING VEHICLES

#### 1 OVERVIEW

- 1.1 The INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA (ICASA), Radio Monitoring & Regions department is presently in the process of upgrading the existing two Special Radio Monitoring DF vehicles. The vehicles are currently fitted with DF and support systems that need to be upgraded in accordance with specifications:
  - 1.1.1 Software Functional Specification, Issue 2.0, dated 5 November 1997.
  - 1.1.2 GIS Overview Specification, Issue 1.0, dated 9 April 2002.
  - 1.1.3 DF vehicle upgrade overview specification, Issue 1.0, dated 9 April 2002.
  - 1.1.4 Specifications are attached.

#### 2 SCOPE

2.1 This tender addresses the upgrade of a mobile DF system consisting of Thompson-CSF DF unit with associated controller, general control computer, GIS and automation software. The GIS software will be supplied and integrated with the automation software. The automation software will be upgraded to fulfil all the requirements. Other sub-systems of the vehicle will not be upgraded.

#### 3 GENERAL CONDITIONS OF TENDER

#### PAYMENT TERMS

- 5.3 Payment by ICASA will be made strictly as follows:
- 5.4 An advance payment of 30% against the necessary bank guarantee.
- After delivery and installation of the hardware, inclusive of all items supplied by the bidder, a test demonstration of the full system by the bidder, an amount of 50% of the total cost will be paid.

- 2.3.11 All antennas forming part of the monitoring equipment shall be tested for correct functionality. A written report including measured VSWR values shall be supplied by the contractor upon completion of contract.
- 2.3.12 A cable calibration test shall be done on all sites mentioned in this tender and the results shall be entered into the Argus software.

#### 2.4 ROTATOR REQUIREMENTS

2.4.1 Pricing on two types of rotator drums is to be supplied. One type to be manufactured from galvanised mild steel and the other to be manufactured from powder coated stainless steel.

A sample of the rotator is available for inspection at Pin Mill Farm, Sandton for further specification purposes.

- 2.4.2 The rotator controller is to be fully tested and repaired where necessary.
- 2.4.3 The rotator motor and gearbox is to be fully tested and repaired where necessary.
- 2.4.4 The antenna relay switch is to be fully tested and repaired where necessary.

#### 3. GENERAL REQUIREMENTS

- 3.1. The quotation must be itemised in respect of direct work on the major subsystems, equipment replacements as well as all new proposals.
- 3.2. The proposal must incorporate the following improvements on characteristics:
  - 3.2.1. A site visit may be required before tender submission
  - All costs incurred for such a visit will be for the tenderer's account.
  - 3.2.2. Equipment that can be refurbished must not be replaced unless it is outdated.
  - 3.2.3. The overall appearance of the mast must be reviewed and restored to a professional standard.
- 3.3. The contractor shall at all times observe proper and adequate safety precautions on site.

It shall also include a functional check of all the equipment after being refurbished. Together with a design review, any possible additions, replacements or modification proposals to the main sub-systems are invited and will be considered on merit before closing of the contract.

# 4 GENERAL CONDITIONS

- 4.1 The successful contractor must reach agreement with the Manager; Radio Monitoring on all items of new design and modifications to the masts before work commences.
- 4.2 The proposals shall include a detailed scope of work including project management and regular progress meetings with ICASA.
- 4.3 ICASA reserves the right to cancel the tender should no acceptable proposal be received.
- 4.4 The onus is on the contractor to familiarise themselves with the current installation configuration, by appointment with the Central Monitoring Office in Johannesburg.
- 4.5 The contractor shall guarantee all work and materials for a period of one year after acceptance by ICASA.
- 4.6 ICASA reserves the right to inspect at any time the work done or in progress for the duration of the contact.

# 5 PAYMENT CONDITIONS

- 5.1 Payment by ICASA will be made strictly as follows:
- 5.2 After delivery, installation of the hardware and completion of all labour, an amount of 70% of the total cost will be paid.
- 5.3 A further 20% of the total cost will be paid after full commissioning of the system, provided that the system is fully operational in accordance with the requirement of ICASA and that a representative of ICASA has issued a certificate of conformance
- 5.4 The final 10% of the total cost will be payable after 3 (three) months of trouble free operation of the system, on full acceptance and on certification by a representative of ICASA.
- 5.5 Advance payment will be considered upon request.

# 6 DELIVERY AND ACCEPTANCE

- 6.1 Acceptance Test Procedures must be developed beforehand by the successful bidder and delivered to ICASA for approval.
- 6.2 ICASA reserves the right to inspect any test procedures and/or ask for any test demonstration. All testing will be done in strict accordance with accepted testing procedures. The successful bidder will be responsible for supplying their own equipment for testing of the hardware if necessary.
- 6.3 Final commissioning and acceptance: Testing must be done after installation of all hardware. Testing shall be done on subsystems as well as for the complete system. The final system will be demonstrated to ICASA representatives. Full field tests will be performed in conjunction with ICASA staff. Final acceptance

will include commissioning and will be done in accordance with the developed test procedures and representatives of ICASA and the contractor will sign all acceptance forms.

# 7 GENERAL CONDITIONS OF TENDER

- 7.1 The bidder to complete all forms contained in this specification in their entirety. Failure to comply can invalidate the bidder proposal.
- 7.2 The tender must be a single tender.
- 7.3 Tenders must be valid for a period of 60 (sixty) days.
- 7.4 Tender documents must be supplied in duplicate (hardcopy) and electronic copy (MS-Word) and must include full technical specifications and manuals where applicable.
- 7.5 Notwithstanding any possible shortcomings in the specifications, bidders must ensure that the solution offered will form a complete and efficient system.
- 7.6 Requests by ICASA for any additional information to be supplied by the bidders must be submitted within 7 (seven) days of such request being made. Failure to comply may invalidate the tender.
- 7.7 All costs must be itemised and must be compatible with the payment schedule and furthermore comply with the conditions of section 5. Supplying a single price only will disqualify a tender.

- 7.11 Payment for items delivered will be done in accordance with the payment schedule as set out in clause 1 of General Conditions.
- 7.12 Ownership of the equipment that has been delivered will only pass to ICASA after it has been officially accepted. For that reason the bidder must, at his own expense, make arrangements for the necessary insurance of the equipment until such date as it has been finally accepted.
- 7.13 Any costs resulting from the preparation of the proposal shall be for the bidder's account.

# 8 GENERAL TENDER INFORMATION

- 8.1 Bidders must tender in accordance with a statement of work with appropriate time scales in sufficient detail in order to enable ICASA to make a good assessment of the solution tendered.
- 8.2 Bidders must indicate compliance or non-compliance on a paragraph by paragraph basis on the GENERAL CONDITIONS of tender as well as the TECHNICAL SPECIFICATIONS. Should the bidder fail to indicate this compliance, ICASA will assume that the bidder is not in compliance with the specifications.
- 8.3 This tender and all information in connection therewith shall be held in strict confidence by bidders and usage of such information shall be limited to the preparation of the tender. Bidders shall undertake to limit the number of copies of this document and to destroy them, in the event of their failure to secure the contract
