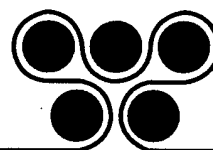

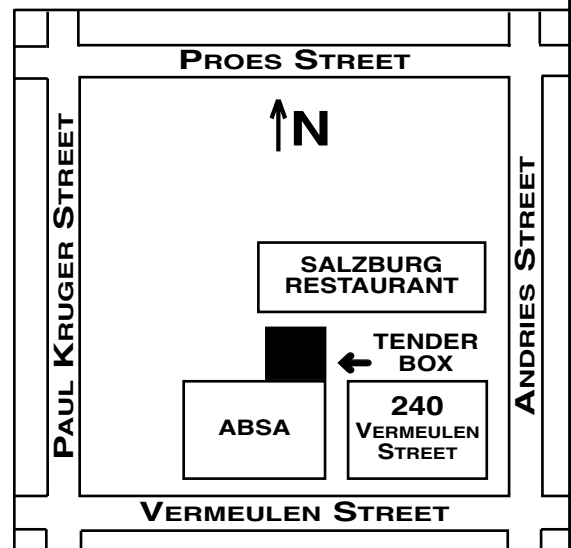

The proposed amendments to the CIDB regulations provide for improved and simplified registration requirements, adapting grading criteria and tender value ranges to provide for inflation and alignment of legal procedures.
