

- vi. Curriculum readiness.
- viii. School management.
- 3. A description of the general state of school infrastructure in the province.
- 4. An assessment of the credentials of the teaching staff (this can be a sample across districts in the province).
- 5. An analysis of current policy interventions within the education sectors (eg no-fee schools, school nutrition programmes, the provision of learner support material, introduction of occupation specific dispensation for teachers and other teacher rewards regimes, etc).
 - 6. An informed assessment of the adequacy of budgetary allocations to education.
 - 7. A proposal on a set of performance indicators that can be measured over time.
 - 8. A clear set of policy propositions for consideration.
 - 9. Any other relevant issue that the research team considers appropriate.
