REMINDER TO PAY SERVICE PROVIDER (VODACOM) IN 30DAYS

TRANSVERSAL CONTRACT RT15-2016 FOR THE SUPPLY AND DELIVERY OF MOBILE COMMUNICATION SERVICES TO THE STATE FOR THE PERIOD ENDED 31 MARCH 2021

Treasury Regulation 8.2.3 states that unless determined otherwise in a contract or other agreement, all payments due to creditors must be settled within 30 days from receipt of an invoice or, in the case of civil claims, from the date of settlement or court judgement.

This amendment serves as a reminder to Participants of RT15-2016 to settle invoices within the stipulated period as non-payments have adverse financial implications on the Service Provider.

Participants of RT15-2016 must not make any excuse with the participation process on the new RT15-2021 and not pay for services rendered by Vodacom (Pty) Ltd (Vodacom) on the active contracts emanated on RT15-2016.

Vodacom has a right to cease the provision of services where it is not paid as instructed by National Treasury on the below instruction notes and the reasons are not justifiable.
