AMENDMENT 4

MEDICAL EQUIPMENT WITHOUT A 5 YEAR COMPREHENSIVE MAINTENANCE PLAN

TRANVERSAL CONTRACT RT2-2021 FOR THE SUPPLY, DELIVERY, INSTALLATION, COMMISSIONING AND MAINTENANCE OF MEDICAL EQUIPMENT TO THE STATE FOR THE PERIOD 1 DECEMBER 2021 TO 30 NOVEMBER 2024

1. It must be noted that some of the medical equipment items were awarded without an option of a 5-year Comprehensive Maintenance Plan because it was not cost effective for Government.
2. National Treasury has obtained the labour hourly rates for the 5-year Comprehensive Maintenance Plan as part of the transversal contract.
3. Participants who wish to enter into a 5-year Comprehensive Maintenance Plan Contract of such medical equipment must approach their Supply Chain Management (SCM) in the province to engage with the respective Suppliers. The engagement should include the technical end-user to discuss the details of the maintenance being sought.
4. Upon completion of the discussions, Suppliers must issue Participant with a proposal that SCM must evaluate against the National Treasury rates, where possible SCM to reduce rates by further negotiations before any procurement of the 5-year Comprehensive Maintenance Plan.

5. The labour hourly rates are listed on Table 1. Participants must note that these labour hourly rates will take effect immediately after the expiry of the 2-year warranty.
6. The renegotiation terms and conditions are informed by the clause 16.10.4 of the Special Conditions of the Contract, which states as follows:

“Participating State institution not procuring the Maintenance Plan”

- 16.10.4.1 The Supplier(s) to provide the labour hourly rate for maintenance of Medical Equipment, for cases where the institutions do not partake in the five (5) year Comprehensive Maintenance Plan.
- 16.10.4.2 The price offered for labour hourly rate will be evaluated with the Medical Equipment price.
- 16.10.4.3 Supplier(s) must not charge for any travelling, accommodation, and any equipment assessment as this is a National Transversal Contract.


