MANUFACTURER'S WARRANTY – 10 YEARS

EXCEPTIONS

The items specified below are covered for different periods from the WARRANTY PERIOD applicable to BASIC WARRANTY COVERAGE.

- **Battery:**
The original equipment battery is fully covered for the first 12 months of the WARRANTY PERIOD regardless of kilometres.
- **Air Conditioner Refrigerant Gas:**
Air Conditioner Refrigerant Gas is covered for the first 12 months of the WARRANTY PERIOD regardless of kilometres. Over the balance of the WARRANTY PERIOD, the refrigerant charge is covered only when replenished as part of a REPAIR under the BASIC WARRANTY COVERAGE.
- **Car Audio:**
Car Audio* is covered for the first 12 months of the WARRANTY PERIOD regardless of kilometres.
(*Please refer to the Radio Owner's Manual provided with your KIA Vehicle.)
- **Tyres:**
Tyres are warranted by the tyre manufacturer.

TERMINATION

KIA shall be entitled to terminate the Warranty forthwith in the event that any defect covered by the Warranty is caused as a direct result of:

- The VEHICLE being altered or modified or tampered with by a third party.
- The installation of parts other than genuine KIA parts.
- The repair of the VEHICLE or the replacement of parts by any person or entity other than a KIA Dealer.
- The VEHICLE being abused or misused, for example, driving over curbs and overloading the VEHICLE.
- The failure to observe KIA's directions concerning the care and usage of the VEHICLE as prescribed in the Owner's Manual, in particular, if the VEHICLE is not serviced at the Service Intervals prescribed in this booklet by KIA Dealer's.
- The VEHICLE not being used for its intended normal purpose, in particular, the overloading of the VEHICLE and the VEHICLE being used in racing events, rallies or other motor sport competitions.
- KIA shall also be entitled to terminate the Warranty forthwith in the event that the odometer has been altered or tampered with.



EXCLUSIONS

Claims arising from any of the events that may give rise to KIA's right to terminate the Warranty as aforesaid.

Claims for damages due to events beyond KIA's control:

- Accidents, collisions, fire, theft, riot, or any other incident caused solely or partly by any negligent act or omission.
- Surface corrosion caused by the environment such as acid rain, airborne fallout (chemicals, tree sap, etc.), salt, road hazards, hail, windstorm, lightning, and other force majeure acts.
- Cosmetic conditions or surface corrosion caused by stone chips or scratches to the paint.

Claims for damages due to any of the following events:

- Lack of proper maintenance as described in the Owner's Manual.
- Improper maintenance or use of other than the specified fuel, oil or lubricants recommended in the Owner's Manual.
- Normal deterioration - Normal wear, tear or deterioration such as discoloration, fading, deformation etc.
