The following information regarding the contract circular must be noted:

OUTSTANDING CATEGORIES

Please note that the following categories of vehicles are not published with the contract circular as there is information that needs to be verified. To avoid delays on the categories that are finalised, the contract circular is issued without the below categories:

- 1. Category 04: Multi-Purpose Vehicle / Sport Utility Vehicle (MPV/SUV)
- 2. Category 05: Buses
- 3. Category 06: Panel Vans

CLASSIFICATIONS OF GENERAL PURPOSE AND SUBSIDISED VEHICLES

The National Treasury in consultation with the National Department of Transport is finalising a classification model to determine vehicles that can be procured as part of the Subsidized Motor Transport Scheme. Once the model has been finalised the pricing list dated 25 July 2023 will be updated to make provision of the classification of the vehicles on contract.

REVISION OF CONTRACT PRICE ADJUSTMENT PERIODS
