ACT

To appropriate an additional amount of money for the requirements of the Department of Public Enterprises to settle the debt obligations of the South African Airways SOC Limited (SAA); and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Appropriation of additional amount of money for the requirements of Public Enterprises

- **1.** (1) An amount of R5 billion is hereby appropriated out of the National Revenue Fund for the requirements of the Department of Public Enterprises in the 2018/19 financial year in order to settle debts due by the South African Airways SOC Limited (hereinafter referred to as the SAA).
- (2) (a) Subject to the Public Finance Management Act, 1999 (Act No. 1 of 1999), the accounting officer of the Department of Public Enterprises must transfer to the SAA the amount, referred to in subsection (1), in the portions and on such dates as the Minister of Finance determines, taking into account the financial position of the SAA as verified by the National Treasury.
- (b) For the purpose of promoting transparency and the effective management of the amount referred to in subsection (1), the Minister of Finance must, in writing—
 - (i) impose conditions to be met by the SAA before any part of the amount is transferred;
 - (ii) impose conditions to be met by the SAA after the transfer of any part of the amount; and
- (iii) stop the use of any part of the amount in respect of which conditions have been 20 imposed in terms of subparagraph (ii), until such conditions are met.
- (c) The National Treasury must disclose the stoppage of an allocation in terms of paragraph (b)(iii) in its next quarterly report to the Standing Committee on Finance of the National Assembly and the Select Committee on Finance of the National Council of Provinces.
- (d) Any part of the amount referred to in subsection (1) not transferred to the SAA by 31 March 2019, reverts to the National Revenue Fund.

Short title

- **1.** (1) Madi a a kana ka R5 bilione a lekanyetswa go tswa mo Letloleng la Lotseno la Setšhaba mabapi le ditlhokego tsa Lefapha la Dikgwebo tsa Setšhaba mo ngwageng wa ditšhelete wa 2018/19 gore go duelelwe dikoloto tsa *South African Airways SOC Limited* (e fano e kaiwang jaaka SAA).
- (2) (a) Go latela *Public Finance Management Act*, 1999 (Molao 1 wa 1999), motlhankedi wa ditshupatlotlo wa Lefapha la Dikgwebo tsa Setšhaba o tla fetisetsa go 10 SAA madi a a kailweng mo karolotlaleletsong (1), ka dikarolwana gape la ka matlha a a tlhomamisitsweng ke Tona ya Matlotlo, ka kelotlhoko go maemo a ditšhelete a SAA go ya ka moo Lefapha la Matlotlo a Bosetšhaba le netefaditseng ka teng.
- (b) Mabapi le maitlhomo a go tsweletsa ponalatshego le botsamaisi jo bo nonofileng jwa madi a a kailweng mo karolotlaleletsong (1), Tona ya Matlotlo o tshwanetse, ka go 15 kwala—
 - go pateletsa dipeelo tse di tshwanetseng go fitlhelelwa ke SAA pele ga karolo efe ya madi e ka fetisetswa;
 - go pateletsa dipeelo tse di tshwanetseng go fitlhelelwa ke SAA morago ga phetisetso ya karolo nngwe le nngwe ya madi; le
 - (iii) go thibela tiriso ya karolo efe ya madi e mabapi le dipeelo tseo di pateleditsweng go ya ka temanatlaleletso (ii), go fitlhela dipeelo tseo di fitlhelelwa.
- (c) Lefapha la Matlotlo a Setšhaba le tshwanetse go senolela Komiti ya Leruri ya Matlotlo ya Kokoanong Bosetshaba le Komitikgetho ya Matlotlo ya Khansele ya Bosetšhaba ya Diporofense ka ga go emiswa ga tekanyetso go ya ka temana (b)(iii) mo 25 pegelong ya yona ya kotara nngwge le nngwe.
- (d) Karolo nngwe ya madi a a kailweng mo karolotlaleletsong (1) a a sa fetisetswang go SAA ka di 31 Mopitlwe 2019, e busetswa kwa Letloleng la Lotseno la Bosetšhaba.
