Details of adjustments to Estimates of National Expenditure 2006

Roll-overs – R230,925 million

Programme 3: Bio-security and Disaster Management

R176,657 million has been rolled over for controlling the classical swine fever outbreak in the Eastern Cape. R8,958 million has been rolled over for compensation of employees under classical swine fever. R45,31 million has been rolled over for the compensation of farmers.

Unforeseeable and unavoidable expenditure – R75,219 million

Programme 3: Bio-security and Disaster Management:

R16,9 million has been allocated for controlling foot and mouth disease in Limpopo.

R12,916 million is allocated for controlling avian influenza in Western Cape.

R33 million is allocated for flood disasters in the Western Cape region, and R12,403 million for flood disasters in the Eastern Cape region.

Selected expenditure trends for the first half of the 2006/07 financial year

Expenditure in the first six months of 2006/07 was R948,209 million, or 40 per cent of the adjusted appropriation of R2,368 billion for the year as a whole.

The year-on-year increase in the transfer to household relates to the higher budgeted allocation for the broad-based black economic empowerment programme for agriculture (AgriBEE).
