FREQUENTLY ASKED QUESTIONS

Q. What must I have in order to be considered for the National Treasury Graduate Development Programme?

A. Graduates must be in their final year or have completed their degrees and or post graduate studies with an average of 60% or higher and must be South African citizens. A comprehensive selection process is also followed, including and not limited to interviews and case studies.

Applicants must have an average of 60% or higher (Preference will be given to high performing students with top grades)

Q. What is the salary offering?

A. Interns are offered a market related salary.

Q. What kind of development initiatives will I be exposed to while on the Internship Programme?

A. All interns receive on-the-job training and will attend learning interventions both behavioural and technical arranged by the Department. There will be a learning agreement between the line manager and the intern to ensure that interns are developed accordingly.

Q. Where would I be based during the programme?

A. All interns will be based at the National Treasury's offices in Pretoria.

Q. How long is the Internship Programme, and what happens thereafter?

A. The internship programme runs for twenty-four (24) months. Permanent placement in the department after the programme is not guaranteed.

Q. Would I qualify for leave?

A. Interns qualify for certain types of leave.
