# BILL

**To appropriate amounts of money for the requirements of the State in respect of the financial year ending 31 March 2001.**

**B**E IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

## **Appropriation of amounts of money for requirements of State**

**1.** Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), there are hereby appropriated out of the National Revenue Fund for the requirements of the State in respect of the financial year ending 31 March 2001, the amounts of money as set out in column “Vote” under column 1 of the Schedule. 5

## **Short title**

**2.** This Act is called the Appropriation Act, 2000.
