# BILL

**To amend the Division of Revenue Act, 2012, in accordance with the Money Bills Amendment Procedure and Related Matters Act, 2009; and to provide for matters connected therewith.**

## PREAMBLE

**WHEREAS** section 214(1) of the Constitution of the Republic of South Africa, 1996, requires an Act of Parliament to provide for—

- (a) the equitable division of revenue raised nationally among the national, provincial and local spheres of government;
- (b) the determination of each province's equitable share of the provincial share of that revenue; and
- (c) any other allocations to provinces, local government or municipalities from the national government's share of that revenue, and any conditions on which those allocations may be made;

**WHEREAS** the Division of Revenue Act, 2012 (Act No. 5 of 2012), gives effect to section 214(1) of the Constitution in respect of the 2012/13 financial year;

**AND WHEREAS** section 12(4) of the Money Bills Amendment Procedure and Related Matters Act, 2009 (Act No. 9 of 2009), requires the Minister of Finance to table a division of revenue amendment Bill with a revised fiscal framework if the adjustments budget effects changes to the Division of Revenue Act for the relevant year,

**B**E IT THEREFORE ENACTED by the Parliament of the Republic of South Africa, as follows:—

### **Substitution of Column A of Schedules 1, 2, 4, 5, 6 and 7 to Act 5 of 2012**

1. (1) Column A of Schedule 1 to this Act is hereby substituted for Column A of Schedule 1 to the Division of Revenue Act, 2012 (hereinafter referred to as the principal Act) setting out the equitable division of revenue raised nationally among the national, provincial and local sphere of government for the 2012/13 financial year. 5

(2) Column A of Schedule 2 to this Act is hereby substituted for Column A of Schedule 2 to the principal Act setting out each province's equitable share of the provincial sphere's share of revenue raised nationally for the 2012/13 financial year. 10

(3) Column A of Schedule 3 to this Act is hereby substituted for Column A of Schedule 4 to the principal Act specifying the allocations to provinces and municipalities for the 2012/13 financial year to supplement the funding of programmes or functions funded from provincial and municipal budgets, respectively.

(4) Column A of Schedule 4 to this Act is hereby substituted for Column A of Schedule 5 to the principal Act specifying the specific purpose allocations to provinces for the 2012/13 financial year. 15

(5) Column A of Schedule 5 to this Act is hereby substituted for Column A of Schedule 6 to the principal Act specifying the specific purpose allocations to municipalities for the 2012/13 financial year. 20

(6) Column A of Schedule 6 to this Act is hereby substituted for Column A of Schedule 7 to the principal Act specifying allocations-in-kind to provinces and municipalities for designated special programmes for the 2012/13 financial year.

**Short title**

2. This Act is called the Division of Revenue Amendment Act, 2012.

## **MEMORANDUM ON THE OBJECTS OF THE DIVISION OF REVENUE AMENDMENT BILL, 2012**

### **1. BACKGROUND**

- 1.1 Section 214(1) of the Constitution of the Republic of South Africa, 1996, requires that an Act of Parliament be enacted to provide for—
- (a) the equitable division of revenue raised nationally among the national, provincial and local spheres of government;
  - (b) the determination of each province's equitable share of the provincial share of that revenue; and
  - (c) any other allocations to provinces, local government or municipalities from the national government's share of that revenue, and any conditions on which those allocations may be made.
- 1.2 Section 12(4) of the Money Bills Amendment Procedure and Related Matters Act, 2009 (Act No. 9 of 2009), requires the Minister of Finance to table a division of revenue amendment Bill with a revised fiscal framework if the adjustments budget effects changes to the Division of Revenue Act for the relevant year. As the adjustments budget for 2012 effects changes to the Division of Revenue Act, 2012 (Act No. 5 of 2012) ("the DoRA"), it is necessary for the Division of Revenue Amendment Bill, 2012 ("the Bill"), to be tabled with the adjustments budget.
- 1.3 The Bill is thus introduced in compliance with the requirements of the Constitution and the Money Bills Amendment Procedure and Related Matters Act, 2009.

### **2. SUMMARY OF BILL**

- 2.1 Clause 1 of the Bill provides for the substitution of Column A of Schedules 1, 2, 4, 5, 6 and 7 to the DoRA, which specify the allocations for the 2012/13 financial year, for Column A of Schedules 1, 2, 3, 4, 5 and 6 to the Bill. Amendments to allocations are indicated in Column A by indicating the adjustment and the adjusted amount. The Schedules to the Bill address the following matters:
- (a) Additional unconditional and conditional allocations to provinces and municipalities;
  - (b) the allocation of unallocated conditional allocations to provinces and municipalities;
  - (c) the re-allocation of conditional allocations in terms of section 19 of the DoRA;
  - (d) roll-overs of conditional allocations to provinces and municipalities not transferred by national departments during the 2011/12 financial year; and
  - (e) increases to a conditional allocation to a province or municipality through a virement under section 43 of the Public Finance Management Act, 1999 (Act No. 1 of 1999), or section 28(2)(d) of the Local Government: Municipal Finance Management Act, 2003 (Act No. 56 of 2003), as the case may be.
- 2.2 Clause 2 of the Bill provides for the short title.

### **3. ORGANISATIONS AND INSTITUTIONS CONSULTED**

The following institutions were consulted on the adjustments proposed in the Bill:—

- Financial and Fiscal Commission;
- South African Local Government Association; and
- National and provincial departments.

#### **4. FINANCIAL IMPLICATIONS TO THE STATE**

This Bill is necessitated by the proposed national adjustment budget for the 2012/13 financial year which affects the division of revenue between the three spheres of government. Financial implications to government are limited to the total transfers to provinces and local government as indicated in the Schedules to the Bill.

#### **5. CONSTITUTIONAL IMPLICATIONS**

This Bill, in conjunction with the DoRA, gives effect to section 214 of the Constitution.

#### **6. PARLIAMENTARY PROCEDURE**

- 6.1 The State Law Advisers and the National Treasury are of the opinion that this Bill must be dealt with in accordance with the procedure envisaged by section 76(1) of the Constitution, as it provides for legislation envisaged in Chapter 13 of the Constitution and as it includes provisions affecting the financial interests of the provincial sphere of government, as contemplated in section 76(4)(b) of the Constitution.
- 6.2 The State Law Advisers are of the opinion that it is not necessary to refer this Bill to the National House of Traditional Leaders in terms of section 18(1)(a) of the Traditional Leadership and Governance Framework Act, 2003 (Act No. 41 of 2003), since it does not contain provisions pertaining to customary law or customs of traditional communities.

**EXPLANATORY MEMORANDUM TO  
THE DIVISION OF REVENUE  
AMENDMENT**

# Explanatory memorandum to the division of revenue amendment

## ■ Background

The allocation of resources to the three spheres of government is a critical step in the budget process, required before national government, the nine provinces and 278 municipalities can determine their own budgets. The allocation process takes into account the powers and functions assigned to the three spheres of government. The process for making this decision is at the heart of cooperative governance as envisaged in the Constitution.

To foster transparency and ensure smooth intergovernmental relations, section 214(1) of the Constitution of the Republic of South Africa, 1996, requires that every year a Division of Revenue Act determine the equitable division of nationally raised revenue between the three spheres of government. The Intergovernmental Fiscal Relations Act, 1997 (Act No. 97 of 1997) prescribes the process for determining the equitable sharing and allocation of revenue raised nationally. The Division of Revenue Amendment Bill fulfils the requirement set out in section 12(4) of the Money Bills Amendment Procedure and Related Matters Act, 2009 (Act No. 9 of 2009), that the Minister of Finance must table a division of revenue amendment bill with the revised fiscal framework if the adjustments budget effects changes to the Division of Revenue Act for the relevant year. Section 10(5) of the Intergovernmental Fiscal Relations Act requires that the Division of Revenue Bill must be accompanied by an explanatory memorandum detailing how the Bill takes account of the matters listed in sections 214(2)(a) to (j) of the Constitution, government's response to the recommendations of the Financial and Fiscal Commission (FFC), and any assumptions and formulae used in arriving at the respective divisions among provinces and municipalities. As the FFC's recommendations are specific to the main budget and none of the formulae used in the Division of Revenue Act, 2012 (Act No. 5 of 2012 – herein called “the 2012 DoRA”) have been changed, this explanatory memorandum only contains two parts:

- Part 1 describes the factors that inform the division of resources between the three spheres of government.
- Part 2 describes the amendments to the 2012 division of revenue and their impact on the different spheres of government.

The Division of Revenue Bill and its underlying allocations are the culmination of extensive consultation processes between national, provincial and local government. The Budget Council deliberated on the matters discussed in this memorandum. The approach to local government allocations was discussed with organised local government (South African Local Government Association) at technical meetings, culminating in a meeting of the Budget Forum on 8 October 2012.

## ■ Part 1: Constitutional considerations

Section 214 of the Constitution requires that the annual Division of Revenue Act be enacted only after taking account of factors in section 214(2)(a) to (j) of the Constitution. These include the national interest, provision for debt, needs of National Government and emergencies, the allocation of resources to provide basic services and meet developmental needs, fiscal capacity and efficiency of the provincial and local spheres, reduction of economic disparities, and promotion of stability and predictability. Annexure W1 submitted with the Division of Revenue Bill, 2012, outlined in detail how these considerations were taken into account in the 2012 division of revenue. None of the adjustments in the Division of Revenue Amendment Bill (“the Bill”) alter the constitutional considerations that informed the 2012 division of revenue.

## Part 2: Summary of changes in the 2012 division of revenue amendment bill

An adjustments budget provides for unforeseen and unavoidable expenditure; appropriation of monies already announced during the tabling of the annual budget (but not allocated at that stage); the shifting of funds between and within votes where a function is transferred; the utilisation of savings; and the roll-over of unspent funds from the preceding financial year. If the adjustments budget effects changes to the division of revenue, as contained in the Division of Revenue Act for the relevant year, the Minister of Finance must table a division of revenue amendment Bill with the revised framework. There are amendments to the 2012 Budget that affect the 2012 DoRA, which will be effected through the Bill, once enacted. The amendments as they impact on provinces and municipalities are discussed in detail below.

### Provincial allocations

#### *Improvements in conditions of service (ICS)*

The provincial equitable share is adjusted upwards by R4 billion to provide for higher than budgeted wage agreements. Provinces were advised to budget for wage increases of 5 per cent but labour and government agreed to a 7 per cent increase. The R4 billion will fund the 2 per cent difference and covers the full wage agreement which includes: salary increase for 11 months of the fiscal year, the increase of the housing allowance from R800 to R900 per month effective from April 2012, long service recognition cash awards and night shift allowances. This amount is shared between provinces in proportion to their shares of personnel numbers as at 31 March 2012. The adjustments per province for improvements in conditions of service (ICS) and the adjusted provincial equitable share per province are shown in Schedule 2 to the Bill (proposing changes to Schedule 2 to the 2012 DoRA).

The *further education and training (FET) colleges grant* is adjusted by R87.3 million for the higher than budgeted wage agreements. These funds are allocated for the same purpose as the adjustments to the Provincial Equitable Share explained above and are shared between provinces in proportion to their share of personnel in FET colleges. The adjustments per province for ICS in FET Colleges and the adjusted baselines per province are shown in Schedule 3 to the Bill (proposing changes to Schedule 4 to the 2012 DoRA).

The distribution of funds available for ICS is shown in Table 1 below.

#### *Adjustments to conditional grants*

A new conditional grant will be established as a once-off allocation to provinces for the provision of health and medical services for the 2013 Africa Cup of Nations (AFCON) scheduled from 18 January to 10 February 2013, and all related official events. An amount of R15 million is allocated to five provinces and the allocations for each province are shown in Schedule 4 to the Bill (proposing changes to Schedule 5 to the 2012 DoRA).

Adjustments for two conditional grants in the health sector are made to provide for unforeseen and unavoidable expenditure. The adjustments per province and the adjusted baselines for these grants are shown in Schedules 3 and 4 to the Bill. The adjustments are as follows:

The *health infrastructure grant* is adjusted by R180 million; and

The *hospital revitalisation grant* is adjusted by R186 million.

Table 2 below shows all the revisions to the provincial conditional grants:

### *Allocation of unallocated funds*

The *provincial disaster grant* was introduced in the 2011 MTEF to provide for the immediate release of funds in response to disasters. The grant is allocated to the National Disaster Management Centre in the Department of Cooperative Governance as an unallocated grant to provincial government. During the 2012/13 financial year, R850 thousand was approved for disaster response in Limpopo Province. This adjustment has already been published in a Gazette (No. 35478, dated 29 June 2012) in terms of section 26(6)(b) of the 2012 DoRA. Although the adjustment does not form part the Bill, it is described here for information purposes.

## **Local Government allocations**

### *Roll-overs*

When a department does not spend all of the funds allocated to it in a financial year, the remaining funds are returned to the National Revenue Fund. If departments had already committed these funds (or a part thereof) to be spent then they can apply for the funds to be returned to them so that they can meet that commitment. The return of these funds is called a roll-over.

A roll-over of R20 million was approved on the *regional bulk infrastructure grant* as a result of funds committed to projects in 2011/12. The *regional bulk infrastructure grant* is an indirect grant through which the Department of Water Affairs builds bulk infrastructure for water and sanitation and then transfers this infrastructure to municipalities. The focus of the grant is on regional bulk which crosses municipal boundaries.

A roll-over of R17.4 million was approved on the *expanded public works programme integrated grant for municipalities* as a result of funds earned by municipalities not being transferred during 2011/12. These funds were not transferred on time as a result of technical problems with the payment system. This roll-over ensures that municipalities receive the full incentive amounts that they earned for their performance in creating employment.

### *Savings*

Government has instructed national and provincial departments to reduce expenditure where possible over the MTEF period so that these funds can be reallocated to government priorities. As a result of this exercise, amounts of R13.6 million and R138.9 million have been declared as savings on the *regional bulk infrastructure grant* and *rural households infrastructure grant* respectively. The *rural households*



*infrastructure grant* is an indirect grant through which the Department of Human Settlements provides on-site solutions for water and sanitation in rural areas where it is not feasible to provide households with piped services due to dispersed settlement patterns. These are both indirect grants reflected in Schedule 6 to the Bill. Funds for indirect grants are spent by national departments on behalf of municipalities. The reductions in these grants will therefore not impact on the amounts municipalities have budgeted to receive as transfers.

### **Adjustments**

An adjustment to provide cities with an operational grant for hosting the 2013 Africa Cup of Nations (AFCON) championship has been recommended. The grant will have conditions similar to those of the *2010 FIFA World Cup host cities operating grant*. The grant will provide for costs relating to the following:

- the operations of the 2013 Africa Cup of Nations championship;
- team accommodation and referee accommodation on match day-1, local transport for teams and referees;
- event security at the stadiums, training venues and venues within the stadium precinct;
- VIP hospitality;
- medical, disaster management and insurance;
- tournament branding;
- office equipment and competition equipment; and
- volunteer meals, stipends and transport.

Municipalities will have to ensure that they have an operational plan that has been approved by their council and complies with the minimum requirements for the hosting of the 2013 Africa Cup of Nations championship. The total value of the grant will be R123.1 million. This amount will be allocated among the following cities based on their different roles and expenses in hosting the competition:

- eThekweni - R28.9 million (of which R11 million is for the Final Draw);
- Nelson Mandela Bay - R15.9 million;
- Rustenburg - R21.3 million;
- Mbombela - R31.5 million; and
- Johannesburg - R25.5 million.

### **Shifts**

Corrections to the *municipal infrastructure grant* allocations for two municipalities in KwaZulu-Natal are made through the Adjustment Bill. Funds were allocated incorrectly in the 2012 Division of Revenue Act as a result of a technical error. The following corrections are made:

- for Hlabisa Local Municipality an allocation of R11.9 million instead of R21.9 million in 2012/13; and
- for Mtubatuba Local Municipality an allocation of R20.9 million instead of R10.9 million.

This correction will be effected without altering the baseline of the *municipal infrastructure grant*.

An amount of R45.5 million is added to the *expanded public works programme integrated grant for municipalities* to provide for the full incentive amounts earned by municipalities in the third and fourth quarters of the 2011/12 municipal financial year. Under the previous *expanded public works programme incentive grant for municipalities*, payments for the third and fourth quarters were made in the subsequent financial year. This adjustment, funded from savings in the national Department of Public Works, provides additional funds for those municipalities that earned incentive amounts higher than those allowed for in the 2012/13 allocations tabled in February 2012.
