**NATIONAL TREASURY INSTRUCTION NO. 6 OF 2016/2017**

**PROVINCIAL REVENUE FUNDS AND PRIMARY BANKING DETAILS  
IN TERMS OF SECTION 22 OF THE PUBLIC FINANCE MANAGEMENT  
ACT (PFMA)**

**1. PURPOSE**

The purpose of this *Treasury Instruction* is to provide accounting officers and chief financial officers of national departments with the primary banking account details of each province to ensure that deposits into the respective Provincial Revenue Funds are paid into the correct bank accounts.

**2. GENERAL ARRANGEMENTS**

**Intergovernmental Cash Coordination (IGCC) accounts of provinces:**

- 2.1 The accounts held at the Corporation of Public Deposits (CPD) at the South African Reserve Bank (SARB) for the purposes of the Equitable Share transfers to Provincial Revenue Funds are as follows:
