- (1) What was the total number of receipts of official development assistance in the 2005-06 financial year;
- (2) whether he has reported the details of the receipts and allocations of such assistance to Parliament; if not, (a) why not and (b) how can Parliament access this information; if so, what are the relevant details?

### **REPLY:**

In responding to this question, certain clarifications are required with regard to the term Official Development Assistance:

(1) Official Development Assistance received by government is done in terms of international agreements of an administrative nature and can be in the form of technical cooperation (e.g. provision of expertise, technical assistance, training, study tours, secondments etc), or in the form of grants and in this instance, the funds are usually channelled through the RDP Fund.

The total receipts for the 2005/06 financial year via the RDP Fund were R 1 100 998 543.51.

A list of all the agreements processed and tabled by National Treasury which includes the donor and the receipts in foreign currency is attached for easy reference.

Assistance processed by National Treasury and subsequently signed by me are tabled on a regular basis in Parliament as required under Section 231(3) of the Constitution. The relevant details of the agreements are set out in the "Announcements, Tablings and Committee Reports" that are published regularly and are available in Parliament.
