DESCRIPTION OF PROJECT:

TERMS OF REFERENCE FOR THE ASSESSMENT, SIMULATIONS, ETHICS WORKSHOPS, REVIEWER AND MENTOR TRAINING FOR THE CHARTERED ACCOUNTANTS ACADEMY (CAA) FOR A PERIOD OF THREE YEARS.

PERIOD: 3 years from the start of the contract.

The service provider should be available for the duration of the contract.

1. BACKGROUND

National Treasury (NT) is an accredited Registered Training Organisation (RTO) by the South African Institute of Chartered Accountants (SAICA). The objective of the CAA is to develop chartered accountants within the public sector. The CAA is one of the mechanisms through which NT assists departments and constitutional institutions in building their capacity for efficient, effective and transparent financial management as required by Section 6(2) (d) of The Public Finance Management Act of 1999 as Amended.

The programme has to date recruited 115 graduates and 68 of them had qualified as chartered accountants. Over 65% of successful trainees were placed within the public sector.

The CAA was extended to other government institutions that are referred to as primary sites namely: eThekwini, City of Cape Town and City of Joburg Metropolitan Municipalities during 2010. Recruited trainees are allocated to National Treasury and the above-mentioned government institutions in order to expose them to the broader public sector.

The CAA competency framework is composed of the following learning areas:

- Accounting and Reporting (compulsory skill);
- Professional Conduct, Management and leadership, Information technology and personal attributes (compulsory skill).
- Management-decision making and Control and Financial Management (elective skill);
- Taxation (residual skill);
- Auditing and Assurance (residual skill); and
- Risk management and Corporate Governance (residual skill).

2. GOAL AND PURPOSE

The overall goal of this Terms of Reference is to enable assessment and ethics workshops of CAA trainees, training of reviewers and mentors, development of simulation curriculum and facilitatation thereof for the CAA to ensure compliance with the National Treasury policies and South African Institute of Chartered Accountants (SAICA) training regulations.

The specific goal will be achieved through the appointment of suitably qualified and experienced service provider that will work closely with the CAA Directorate.



3. SCOPE OF WORK

Based on the above-mentioned goal and purpose, the service provider will be responsible for delivering on the following scope of work:

3.1 INDUCTION/TRAINING

Provide and induct trainees, reviewers and mentors on the reporting tool and the nature of the SAICA programme;

- Introduce trainees to the SAICA training regulations and report tool for technical and professional skills review;
- Introduce trainees of the structure of the training processes;
- Introduce the SAICA training framework to trainees and reviewers; and
- Introduce the assessment processes and how disputes on rating have to be resolved.

3.2 ETHICS WORKSHOP

Ensure that each trainee completes a formal ethics programme of at least 6 to 8 hours' duration followed by an assignment which allows for individual reflection on the aspects covered. Ethics workshop must among other requirements assist trainees to:

- understand what ethics are;
- understand why ethics are important;
- build reputation and trust through ethics in their career and business;
- understand the consequences of ethical failure;
- identify what drives ethical choices;
- understand different values and how they underpin behaviour in the workplace;
- integrate ethical principles and apply them to scenarios that typically arise in the accounting industry;
- use practical tools to help improve ethical behaviour;
- make ethical decisions in complex situations;
- understand the role of the chartered accountant in ensuring ethical and effective governance in organisations and his/her responsibilities in this regard; and
- build an ethical culture in organisations and understand his/her responsibilities in this regard.

3.3 ASSESSMENT

Assess trainees at intervals prescribed by National Treasury to determine whether they are satisfactorily progressing towards the required levels of competence at entry level into the CA (SA) profession:

- Recommend corrective measures to be implemented to address identified gaps;
- Provide assessment report after each assessment session;
- Advise National Treasury if training contracts needs extension and specify the period;
- Generate cumulative assessment report after each assessment;



- Provide technical advice to ensure that National Treasury complies with all the required systems required by SAICA in its monitoring processes;
- Provide technical advice on all the SAICA requirements with regard to assessment criteria.
- Assist National Treasury in preparing for the SAICA monitoring visits.

Develop an assessment criteria and assessment instrument that will allow for the assessment of the following skills:

- The Technical Skills Review (TSR);
- The Professional Skills Review (PSR); and
- The Assessment Needs Analysis (ANA).

3.4 **REPORTING**

Provision of (or development of) the required trainee reporting templates and forms. Provide written feedback for each trainee based on completed templates and forms, for example:

- Time sheets,
- Technical Skills Review and Professional Skills Review,
- Portfolio of Evidence,
- Evaluation,
- Assessments (performance reviews, two and four monthlies, etc.)

Provide a comprehensive report after each assessment that will detail each trainee's performance and developmental needs for presentation at the CAA Steering Committee.

Recommend, where practical exposure or simulations interventions are not sufficient for achieving a specific outcome:

- Intervention(s) to address the gaps e.g. customised development(s)
- The recommended option(s) should include content, duration, costing and logistics.

3.5 SIMULATIONS

Develop and facilitate in-house simulations for the identified gaps in the following learning areas:

Taxation

- Calculates or evaluates income tax payable and prepares or evaluates income tax returns for individuals;
- Calculates or evaluates income tax payable and prepares or evaluates income tax returns for legal entities.
- Calculates other taxes payable (e.g. withholding tax, indirect taxes, employees' tax, etc) and prepares or evaluates appropriate returns;



4. OUTPUTS

The Selected Service Provider will be responsible to deliver all the aspects mentioned under scope in this document. The Selected Service Provider must take note of the following expected outputs:

4.1 Assessment:

- Assessment of CAA Trainee at intervals prescribed by the National Treasury;
- Development of the reporting tool that meets both National Treasury and SAICA requirements;
- Development of training material for the CAA trainees, reviewers and mentors;
- Provide sufficient training to stakeholders on the proper use of assessment tool;
- Provide technical assistance to the training office about developmental needs analysis for each trainee;
- Resolve rating disputes between trainees and reviewers during assessments;
- Recommend effective rotation and competencies to be acquired at the right level for basic and advanced skills as informed by assessment findings;
- Provide overall technical advice around developments of assessment criteria that require amendment of National Treasury policies.

4.2 **Simulations:**

- Development of simulation curriculum guided by the gaps that must be addressed through simulation for Taxation; and
- Facilitation of simulations to the CAA trainees.

4.3 Training:

- Develop induction programme curriculum that is based on SAICA training regulations for the induction of trainees, reviewers and mentors;
- Facilitate induction to stakeholder identified above based on induction programme curriculum; and
- Facilitate refresher and ethics workshops to all the CAA stakeholders based on developments within the sector/profession.

4.4 **Reporting and advisory services:**

- After each assessment, the service provider should provide written assessment report for each trainee to National Treasury in word and electronic format;
- Provide simulation report in word and electronic format for each trainee after each simulation; and
- Present assessment report at each CAA Steering Committee meeting and provision of advisory services to the Training Officer.



4.5 **Approach:**

The approach should allow the National Treasury and primary sites to become self-sufficient in terms of all training interventions. National Treasury should be able to maintain and sustain the programme internally after handover and transfer of knowledge.

5. PROJECT OUTCOMES

The project is expected to achieve the following outcomes:

- a) Enabling CAA Trainees to meet discharge requirements of their training contracts;
- b) Successful compliance by National Treasury with SAICA accreditation and assessment criteria;
- c) Development of good quality-chartered accountants; and
- d) Successful knowledge transfer to National Treasury officials.

6. QUALIFICATIONS, SKILLS AND EXPERIENCE

6.1 Qualifications

The preferred service provider, project leader and additional resources (assessors) should be a Chartered Accountant (s) South Africa \ CA (SA) as a mandatory requirement.

6.2 Skills and Expertise of project leader

The project leader should have experience and expertise in the following areas:

- i. Should be an accredited assessor;
- ii. At least three years of experience conducting assessments, simulations, training, reporting and online tool. Assessment function cannot be outsourced by the lead personnel;
- iii. Experience on either developing or use of assessment tool, preferably an online tool;

7. TIMEFRAME

The service provider is expected to be available for the duration of the contract period of three years at intervals prescribed by National Treasury for assessment, simulation and training purposes.

8. RESOURCES AND RESPONSIBILITIES

NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if (applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

- 1. Definitions 1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable.

Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

tests and analyses	8.2	If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
	8.3	If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
	8.4	If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.

The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
 - 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.
- 10. Delivery
and documents10.1 Delivery of the goods shall be made by the supplier in accordance with
the terms specified in the contract. The details of shipping and/or other
documents to be furnished by the supplier are specified in SCC.
 - 10.2 Documents to be submitted by the supplier are specified in SCC.
- 11. Insurance 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.
- 12. Transportation 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.
- 13. Incidental13.1 The supplier may be required to provide any or all of the following
services, including additional services, if any, specified in SCC:
 - (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and

- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.
- 14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
 - (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
 - (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.
- 15. Warranty 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
 - 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.
 - 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
 - 15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
 - 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

19. Assignment	19.1	The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
20. Subcontracts	20.1	The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
21. Delays in the supplier's performance	21.1	Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
	21.2	If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s).
