

## **1. INTRODUCTION**

The delivery of infrastructure in the education, health and roads sectors is a key strategic thrust of the South African Government in ensuring socio-economic growth, development, poverty alleviation and social stability. However, there are challenges, risks and opportunities for the Government in delivering on a large quantum of quality infrastructure in these sectors.

The National Development Plan (NDP) 2030 describes these challenges when it explains that in a society with deep social and economic divisions, neither social nor economic transformation is possible without a capable and developmental state. According to the NDP the main challenge which also affects infrastructure management and delivery has been the unevenness in capacity that leads to uneven performance in local, provincial and national government. This is caused by a complex set of factors, including tensions in the political-administrative interface, instability of the administrative leadership, a skills deficit, the erosion of accountability and authority, poor organisational design and low staff morale. The weaknesses in capacity and performance are most serious in historically disadvantaged areas, where state intervention is most needed to improve people's quality of life.

According to the NDP there have been many individual Government initiatives to address weaknesses in the State, but there is a tendency to not give focused attention over an extended period of time. Frequent changes in approaches and interventions have created instability in organisational structures and policy approaches that further strain limited capacity. The search for a quick fix has diverted attention from more sustainable approaches.

As early as 2001 it became evident to the Government that the objective of increased investment in infrastructure will not be achieved by only increasing infrastructure funding flows (largely provided in the form of conditional grants, but supported by the provincial equitable share). When

the Infrastructure Grant to Provinces was introduced to step up delivery for health, education and roads in the provinces, budgets were underspent. It became evident that increased public investment in infrastructure development and maintenance is not only dependent on more funds, but funding must coincide with sufficient capacity to plan and manage the delivery of infrastructure effectively and efficiently. The precondition for providing the right infrastructure that contributes to growth and development is in developing the right enabling institutional environment, in all its dimensions.

Traditional models of service delivery enhancement are simply insufficient for Government to deal with these challenges in a comprehensive manner. It requires co-operation and co-ordination across government (and with the private sector). The Infrastructure Delivery Improvement Programme (IDIP) was thus established as a capacity building programme which aims to build sustainable infrastructure management and delivery capacity in the long term.

## **1. DEVELOPING AN INFRASTRUCTURE DELIVERY MANAGEMENT SYSTEM**

The Infrastructure Delivery Improvement Programme (IDIP) was initiated with a pilot in 2004. Since 2004, IDIP has been through three phases which progressively built capacity and systems in provincial and national government departments.

Strong and effective partnerships were a prerequisite to the success of the programme. IDIP was managed by means of a strong partnership which was institutionalized at the national sphere of government. The IDIP PMU was constituted of senior officials from the national Departments of Basic Education and Health, the National Treasury as well as the Development Bank of Southern Africa (DBSA) and the Construction Industry Development Board (CIDB). The programme was implemented through the Provincial Treasuries and the Provincial Departments of Health, Education.

Phase III of IDIP commenced in April 2010 and was initially designed to close in March 2013, but the Programme was extended for additional year. Over this phase of IDIP, the following activities and outputs were undertaken:

- i. The Infrastructure Delivery Management (IDM) Toolkit<sup>2</sup> was refined, enhanced;

- ii. Construction procurement standards were developed and elevated to strategic importance in the IDM Toolkit in order to promote new options and alternative delivery approaches for infrastructure delivery and procurement;
- iii. A Human Resource Capacitation Framework for infrastructure units, which identifies and defines the core competencies and expertise required to sustain effective infrastructure delivery, was developed for the education and health sectors;
- iv. A foundation and executive training course (referred to as the Infrastructure Delivery Management Programme (IDMP)) was developed and piloted in partnership with the University of Pretoria;
- v. Provinces developed and adopted intergovernmental agreements which define the roles, responsibilities and accountabilities of each department in a system of cooperative government (IDMS Strategic Agreements); and
- vi. A standardised approach to infrastructure delivery management (referred to as the Infrastructure Delivery Management System or IDMS) was developed and incorporated into relevant legislation.

An independent Strategic Review of IDIP, commissioned by the National Treasury and conducted between September and November 2013, found that IDIP made good progress in relation to the areas outlined above – but most specifically in relation to establishing a standardised rule-based intergovernmental system for infrastructure delivery and management.

Nevertheless, although the Programme has made good progress in most areas, the Review exercise also concluded that the IDMS has not been sufficiently institutionalised in most departments. The implementation and sustainability of the IDMS therefore remains a challenge.

Based on the recommendations of the independent Review, National Treasury is thus initiating another phase for the IDIP programme. IDIP Phase IV will focus specifically on embedding the outputs and work done in the previous phase of the programme. The purpose of the Programme, in phase IV, is thus to support the national and provincial partners to sustainably implement the Infrastructure Delivery Management System (IDMS).

This Terms of Reference deals with the need to appoint a suitably qualified and experienced Technical Assistant to assist the Department of Basic Education to strengthen the delivery, oversight, capacitation and support of the Provincial Departments of Education in the provision of infrastructure.



## 2. PURPOSE

The overall purpose of the terms of reference is to contribute to the achievement of Government's Goal of effective and efficient infrastructure delivery. This goal is to be achieved through the appointment of a Public Sector Infrastructure Delivery Management Advisor/Consultant to advise, assist and support the Department of Basic Education on matters relating to the institutionalisation of the IDMS, strengthen the delivery, oversight, capacitation and support of the Provincial Departments of Education in the provision of infrastructure

## 3. SCOPE OF WORK

The Technical Assistant will be responsible for the development and delivery of the following outputs, unless otherwise amended in the work plan:

### 1.1 **Output 1: The IDMS is institutionalised and sustainable in the Education Sector**

- I. Assist and support the Education Sector to comply with the IDMS requirements in DoRA;
- II. Assist and support with the oversight, monitoring of planning and the implementation of infrastructure in the education sector;
- III. Assist and support DBE as an active member of the intra-governmental committee which is established by National Treasury to coordinate and monitor the implementation of the IDMS at the national sphere of government;
- IV. Assist and support the NDBE to monitor Provincial Departments of Education participation in IDMS in accordance with the approved Provincial IDMS Framework Agreements;
- V. Assist and support the usage of IDMS body of knowledge by the education sector's infrastructure units for management, coordination and communication purposes; and
- VI. Support the DBE implementation of the Technical Assistance Agreement between DBE and National Treasury.

### 1.2 **Output 2: The Infrastructure Delivery Management (IDM) processes are implemented and are being used by DBE and the Provincial Departments of Education to plan, implement and assess infrastructure delivery.**

- I. Assist and support the improvement of infrastructure portfolio planning in the Education Sector;



- II. Assist and support the improvement of infrastructure delivery strategies;
- III. Assist and support the improvement of infrastructure implementation planning;
- IV. Assist and support compliance with the National Treasury's Regulations and Standard Operating Procedures (SOPs) to support the IDMS; and
- V. Assist, support and participates in the development of the IDM Toolkit into an integrated IDMS body of knowledge.

**1.3 Output 3: There is appropriate capacity within the DBE and the Provincial Departments of Education to implement and sustain the IDMS in the Education Sector.**

- I. Assist and support the development and implementation of the IDMS organisational structures and competence standards in the Education Sector;
- II. Assist, support and participates in IDMS related training, research and development; and
- III. Assist, support and participates in knowledge sharing and lesson learning initiatives in relation to the IDMS.

**1.4 Output 4: IDMS evaluation, monitoring and reporting systems are implemented and functional in the Education Sector.**

- I. Assist and support the DBE with effective results monitoring and reporting on the implementation of the Technical Assistance Agreement with NT

**4. REQUIRED QUALIFICATIONS, SKILLS AND EXPERIENCE**

**4.1 Qualifications:**

- A minimum of a 3 year Degree in a built environment related discipline, preferably engineering, architecture or quantity surveying; and
- Professional registration with a professional body in the built environment.

**4.2 Skills:**

- In-depth understanding of legislation and strategic frameworks relating to infrastructure asset management and infrastructure delivery management in the public sector;
- In-depth knowledge of the development and implementation of the Infrastructure Delivery Management System and the Standard for Construction Procurement;
- Understanding of portfolio, programme and project management principles as described in the IDMS;



- Strong communication, report writing and presentation skills;
- Ability to successfully engage with multi-disciplinary and multi-cultural teams;
- Ability to facilitate knowledge sharing and capacity building workshops; and
- Ability to present training at higher education institutions.

#### 4.3 Experience:

- Extensive experience in the development and implementation of infrastructure delivery management systems processes and procedures in the public sector [minimum of 10 years' experience];
- Extensive experience in institutional capacity building in public sector infrastructure delivery management;
- Extensive experience in transferring of knowledge and skills to officials responsible for infrastructure delivery in the public sector;
- Experience with and in depth knowledge of the development and implementation of the Infrastructure Delivery Management System and the Standards for Construction Procurement [minimum of 3 years' experience];
- Extensive experience in infrastructure planning in the public sector;
- Extensive experience in the management of infrastructure programmes and projects in the public sector;
- Extensive experience in infrastructure operations and maintenance management in the public sector;
- Extensive experience in construction procurement in the public sector;
- Experience in property portfolio management;
- Experience with the development, design and presentation of training material; and
- Experience and expertise in the design and implementation of programme and project management support structures.

#### 4.4 Timeframe (Project Duration)

The Technical Assistant is required to be available for the period 01 December 2016 to 29 February 2018<sup>4</sup>. The time should be calculated at 160 hours Month (Full time).



#### **4.5 Resources and Responsibilities**

The Technical Assistant will be contracted by the National Treasury, but will be assigned to National Department of Basic Education In relation to the outputs to be delivered Technical Assistant will report to the National Department of Basic Education or to his/her nominated delegate. An inception report, Workplan and Close-out report must be prepared in line with the format provided by IDIP.

#### **4.6 Work plan and Close-Out Report**

The Work plan must be prepared within 21 working days from the date of assumption of duties and such should be signed by the Technical Assistant together with the responsible/delegated official from the National Department of Basic Education.

The Workplan must be developed in a manner that links to the Outputs, Tasks and Activities as contained in the Terms of Reference.

The Technical Assistant will be contracted by the National Treasury, but will be assigned to National Department of Basic Education In relation to the outputs to be delivered Technical Assistant will report to the National Department of Basic Education or to his/her nominated delegate. An inception report, work plan and close report must be prepared in line with the format provided by IDIP.

### 6.1 Logistics

The Technical Assistant will be responsible for providing his/her own laptop, cell phone, printer and access to internet for this assignment. The Client will make provision for all other equipment and supporting infrastructure that will be necessary to successfully deliver on this assignment. National Treasury and its client (NDBE), will not be responsible for any relocation costs should it be necessary for the resource to relocate.

### 6.2 Close Out Process

A draft Close-out report must be developed which links to the Outputs, Tasks and Activities as contained in the Terms of Reference and approved Workplan by the end of the first month of the appointment. Disbursements will be provided at 5% of the proposed (quoted) contract value (Please do not include/add this amount in your quotation). ### *Stage 1: Professional Body affiliation and Minimum Education Required*

Resources who fail to meet any of the requirements below will be disqualified from any further evaluation relating to this Bid.

- Registration with professional bodies that are within a built environment related discipline, preferably (engineering, architecture, quantity surveying or project management) is compulsory, failure or absence thereof should lead to immediate disqualification;
- A Degree in Built Environment.

### *Stage 2: Functional Evaluation*

A two gated evaluation process will be applied:

- Only those tenderers who score a minimum of 35 for their methodology alone will be invited for the interview evaluation, those who do not meet the minimum requirement will be disqualified.

## THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME

### INTRODUCTION

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

### 1 PILLARS OF THE PROGRAMME

- 1.1 The NIP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US\$ 10 million or other currency equivalent to US\$ 10 million will have a NIP obligation. This threshold of US\$ 10 million can be reached as follows:
- (a) Any single contract with imported content exceeding US\$10 million.
  - or
  - (b) Multiple contracts for the same goods, works or services each with imported content exceeding US\$3 million awarded to one seller over a 2 year period which in total exceeds US\$10 million.
  - or
  - (c) A contract with a renewable option clause, where should the option be exercised the total value of the imported content will exceed US\$10 million.
  - or
  - (d) Multiple suppliers of the same goods, works or services under the same contract, where the value of the imported content of each allocation is equal to or exceeds US\$ 3 million worth of goods, works or services to the same government institution, which in total over a two (2) year period exceeds US\$10 million.
- 1.2 The NIP obligation applicable to suppliers in respect of sub-paragraphs 1.1 (a) to 1.1 (c) above will amount to 30 % of the imported content whilst suppliers in respect of paragraph 1.1 (d) shall incur 30% of the total NIP obligation on a *pro-rata* basis.
- 1.3 To satisfy the NIP obligation, the DTI would negotiate and conclude agreements such as investments, joint ventures, sub-contracting, licensee production, export promotion, sourcing arrangements and research and development (R&D) with partners or suppliers.

- 1.4 A period of seven years has been identified as the time frame within which to discharge the obligation.

## **2 REQUIREMENTS OF THE DEPARTMENT OF TRADE AND INDUSTRY**

- 2.1 In order to ensure effective implementation of the programme, successful bidders (contractors) are required to, immediately after the award of a contract that is in excess of R10 million (ten million Rands), submit details of such a contract to the DTI for reporting purposes.

- 2.2 The purpose for reporting details of contracts in excess of the amount of R10 million (ten million Rands) is to cater for multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as provided for in paragraphs 1.1.(b) to 1.1. (d) above.

## **3 BID SUBMISSION AND CONTRACT REPORTING REQUIREMENTS OF BIDDERS AND SUCCESSFUL BIDDERS (CONTRACTORS)**

- 3.1 Bidders are required to sign and submit this Standard Bidding Document (SBD 5) together with the bid on the closing date and time.

**GENERAL CONDITIONS OF CONTRACT**

**NOTES**

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

## General Conditions of Contract

### 1. Definitions

1. The following terms shall be interpreted as indicated:
  - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
  - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
  - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
  - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
  - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
  - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
  - 1.7 "Day" means calendar day.
  - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
  - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
  - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
  - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
  - 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable.

Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

- 2. Application**
- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.
- 3. General**
- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from [www.treasury.gov.za](http://www.treasury.gov.za)
- 4. Standards**
- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
- 5. Use of contract documents and information; inspection.**
- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.
- 6. Patent rights**
- 6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
- 7. Performance security**
- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.

- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
  - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

**8. Inspections,  
tests and  
analyses**

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with

supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

**9. Packing**

9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.

9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

**10. Delivery and documents**

10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.

10.2 Documents to be submitted by the supplier are specified in SCC.

**11. Insurance**

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

**12. Transportation**

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

**13. Incidental services**

13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and

- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

#### 14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
  - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
  - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

#### 15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

- 16. Payment**
- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated in SCC.
- 17. Prices**
- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
- 18. Contract amendments**
- 18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
- 19. Assignment**
- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
- 20. Subcontracts**
- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
- 21. Delays in the supplier's performance**
- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

## **22. Penalties**

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

## **23. Termination for default**

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

## **24. Anti-dumping and countervailing duties and rights**

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable

difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

**25. Force Majeure**

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

**26. Termination for insolvency**

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

**27. Settlement of Disputes**

27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.

27.5 Notwithstanding any reference to mediation and/or court proceedings herein,

(a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and

(b) the purchaser shall pay the supplier any monies due the supplier.

**28. Limitation of liability**

28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;

(a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss

or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

**29. Governing language**

29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

**30. Applicable law**

30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.

**31. Notices**

31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice

31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

**32. Taxes and duties**

32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.

32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.

32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
