

The Republic of South Africa has received funding from the African Development Bank toward Municipal Financial Management Capacity Building Support and intends to apply part of the agreed amount for this funds to payments under the contract for the assessment of the viability of municipalities in the North West Province and Free State.

The services to be delivered under this project include establishing whether municipalities are viable. The assignment seeks to undertake municipal profiling that incorporates the demarcation, economic climate, population demographic, spatial plan and establish linkages to the municipal General Valuation Roll and Supplementary Valuations. The scope of work can be considered in two parts of which (1) is to establish whether the land within the municipal demarcation boundaries has economic earning potential by considering industry, land usage and ownership, population and employment statistics; and (2) is to establish whether the municipality is valuing all properties within its municipal boundaries correctly and whether sound valuation methodologies are applied when compiling property valuation information; and the municipality's capability to effectively render services and collect revenue due from such services. The assignment will be implemented in two provinces, namely North West and Free State. The estimated period of execution is 126 working days (six months).

The National Treasury now invites eligible consultants or consulting firms to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services including brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc. Consultants may constitute joint-ventures to enhance their chances of qualification.

In such cases of associations / consortiums, EOI submissions should clearly identify one lead firm that would take up the primary responsibility of assignment delivery.

This eligibility requirements include: at least a Bachelor's Degree in Commerce or similar qualification with major subjects such as Economics and Statistics. An understanding of the legal framework (Municipal Finance Management Act, Municipal Property Rating Act; Town Planning Ordinances amongst others); understanding of local government service delivery challenges and remedies; ability to assess the property value chain and the importance of the Surveyor General and Deeds Registry in the town planning process; understanding of the Geographic Information System (GIS); Knowledge of sources of economic data and how to interpret the information in relation to the key focus areas identified above; Ability to undertake research, analyse data, compile reports and present findings; and An understanding of the application of the fiscal framework and the ability to undertake municipal budget analysis.
