## **MEDIA STATEMENT**

## PROVISIONAL FINANCING FIGURES ON LOAN ISSUES, NATIONAL REVENUE FUND RECEIPTS/PAYMENTS AND CASH BALANCES AS AT 31 DECEMBER 2022

During the month of December 2022, net domestic short-term loans decreased by R4 357 million. Net domestic long-term loans inclusive of redemptions increased by R14 710 million.

National Revenue Fund receipts of R242 million were recorded resulting mainly from revaluation profits on foreign currency transactions.

Government's cash balances increased by R56 032 million to R364 429 million. The South African Reserve Bank accounts, sterilisation and foreign currency deposits, amounted to R157 446 million. Short-term investment with the Corporation for Public Deposits amounted to R30 000 million. Cash balances with commercial banks amounted to R176 983 million.

More detailed information on the provisional figures will be included in the monthly statements of the National Revenue, Expenditure and Borrowing, which will be released on 30 January 2023.
