### **TO BIDDERS**

### **BID RT2-2025: SUPPLY, DELIVERY, INSTALLATION, COMMISSIONING, TRAINING AND MAINTENANCE OF MEDICAL EQUIPMENT TO THE STATE FOR A FORTY-EIGHT (48) MONTH PERIOD**

1. Bidders are required to take note of the following updates on the RT2-2025 bid:
  - 1.1. **Closing date and Time of Bid** has been extended to 17 December 2024 @ 16h00
  - 1.2. **SBD 1 Invitation to Bid** – This has been revised to be in line with the closing date and time.
  - 1.3. **TCD 13 Authorization Declaration** - This has been revised to be in line with the new closing date.
  - 1.4. **RT2-2025 Special Conditions of Contract** – The document has been updated
  - 1.5. **RT2-2025 Annexure A Technical Specification** for all the groups has been updated. The total number of equipment on the RT25-2025 bid is now 184 in total.
  - 1.6. **RT2-2025 Annexure B Pricing Schedule** has been updated to be in line with the technical specifications (all groups)
  - 1.7. **Submission of Annexure A - Technical Specification Sheet (All Groups) For Each Item Offered** – Bidders must submit a completed **RT2-2025 Annexure A Technical Specification Documents** for relevant items offered only including also the alternative equipment offered on the bid. The technical Sheets must be submitted for all items offered at the closing date and time of the Bid.
  - 1.8. **Manufacturers Technical Specification-Brochures** – Kindly note that the brochures **MUST NOT** be loaded on e-tenders as indicated in paragraph 6.5.16. **ONLY** bidders who comply with **Phase 4 Part A** will be required to submit Manufactures Technical Specification Brochures. The date, time and method of



submission of the brochures will be communicated only to the short-listed bidders for the relevant items.
