RT11-2019: SUPPLY, DELIVERY AND OFFLOADING OF ANIMAL FEEDS TO THE STATE FOR THE PERIOD 1 JULY 2020 TO 30 JUNE 2023.

AUTHORITY TO PURCHASE OUT OF CONTRACT

1. National Treasury, Transversal Contracting (the office) received an email from MRN Consulting Services (Pty) Ltd indicating the inability to deliver on the current approved prices due to the price escalation from their manufacture for the Horse feeds. It is indicated that the main driver behind the variation in feed prices is the ever changing raw material prices that they use in their feed. Moreover, the current Covid-19 pandemic has caused a negative impact on the side of the manufactures regarding the increase of raw material. This has a negative impact on a number of suppliers.
2. The office is in the process of exploring various remedial options to seek alternative solution to the matter indicated above and therefore resolved to provide the user departments with approval to buy out of contract as an interim measure using internal procurement process. Failure to reach a workable solution may result in all the affected items that are awarded to MRN Consulting Services be withdrawn and issued in the supplementary bid.
3. It should be noted that this **interim measure** relating to MRN Consulting Services (Pty) Ltd will be in place as from 21 July 2020 until an alternative solution is reached, of which the office will revert in due course.
4. Furthermore, there are non-awarded items that will be issued in the supplementary bid. The office hereby provide authorization to procure out of contract until the supplementary bid is concluded.
5. As per General Conditions of Contract (GCC) Clause 21.4 to 21.6, you are granted permission to purchase your requirements out of contract within your delegated authority until the new supplementary bid is effective.
6. Procurement of other products supplied on this contract should not be affected by this notice.
