**CONTRACT RT27-2024: PROVISION OF DEBT COLLECTION SERVICES TO THE STATE FOR THE PERIOD OF SIXTY (60) MONTHS.**

1. This contract will be subject to the Transversal Master Agreement Contract and all its annexures issued in accordance with Chapter 16A of the Treasury Regulations published in terms of the Public Finance Management Act, 1999 (Act 1 of 1999). The Special Conditions of Contract and all the annexures are supplementary to that of the Transversal Master Agreement Contract. Where, however, the Transversal Master Agreement Contract is in conflict with the Participation Agreement, General Conditions of Contract and Special Conditions of Contract the Transversal Master Agreement Contract will prevail.
2. The contract circular for the aforementioned contract distributed to State Institutions together with all other annexures constitutes the official and binding agreement between the Service Provider and the State. State Institutions are, therefore, prohibited from making any amendments of any nature to the aforementioned contract, except on the service levels.
3. The National Treasury will communicate all amendments, if any, to the State Institutions. It would only be at the receipt of such notification from the National Treasury that State Institutions can effect any changes to this contract.
4. The documents below will be updated as and when required and therefore State Institutions should always refer to the latest available documents from the National Treasury Website.

## **5. Utilization Guidelines**

- 5.1. State Institutions are encouraged to rotate the above-mentioned Service Providers to ensure maximum successful collection and distribution/allocation of work.
- 5.2. Appointment of multiple service providers is highly encouraged to effectively manage performance of the appointed Service Provider(s), as success will be measured against average performance of the other Service Providers.
- 5.3. State Institutions will identify any of the appointed Service Providers and conclude the Participation Agreement. Once the Participation Agreement is duly signed, the Participant will issue the Service Request(s) with allocated debt book for the duration of six months.
- 5.4. State Institutions are responsible for performance management, supplier relationship management and dispute resolution. Failure to resolve the dispute, both parties may escalate and notify in writing to the National Treasury – Chief Director: Transversal Contracting for further dispute resolution, failing which parties may seek legal advice.
- 5.5. In order to reduce the administration burden, State Institutions must refrain from requesting SBD documents every time they issue a Service Request to the awarded service providers as the competitive process was followed at National Treasury. Upon signing of the Participation Agreement, all the supporting documents must be finished at this stage for the duration of the contract.
- 5.6. State Institutions and Service Providers are required to provide quarterly historic reports of all the services requests issued. The report will indicate the name of the service(s) providers/State Institution, debt book value, expected targeted value, actual collected value, commission fee payable, challenges, opportunities, and success of the contract. This information will be analysed in conjunction and be used for supplier performance management reviews.

## 6. Post Participation

6.1. The National Treasury will continuously add new participants during the tenure of the contract. The interested State Institution will be required to complete the Request for Participation Letter and submit to National Treasury – Chief Director: Transversal Contracting for consideration.

## 7. Contract Circular – Commission Fee Structure:

7.1. The debt collection services offered are on the basis of “No Successful Collection, No Commission Fee” payable. All commission fee percentages are inclusive of 15 % VAT.
