CONTRACT: RT275-2-2024: SUPPLY AND DELIVERY OF SPEECH THERAPY, ASSISTIVE DEVICES, AND ACCESSORIES TO THE STATE FOR THE PERIOD 1 AUGUST 2026 TO 30 NOVEMBER 2027

1. PURPOSE

- 1.1. The purpose of this Contract Circular is to inform the relevant stakeholders concerning the award of the Transversal facilitated by the National Treasury for utilization by participating Organs of State regarding Contract RT275-2-2024: Supply and delivery of speech therapy, assistive devices and accessories to the state for the period ending 30 November 2027.

2. TERMS AND CONDITIONS OF THE CONTRACT

- 2.1. This contract is subject to the General Conditions of Contract issued following Chapter 16A of the Treasury Regulations published in terms of the Public Finance Management Act, 1999 (Act 1 of 1999). The Special Conditions of Contract are supplementary to those of the General Conditions of Contract. Where the Special Conditions of Contract conflicts with the General Conditions of Contract, the Special Conditions of Contract will prevail.
- 2.2. The National Treasury will communicate all amendments, if any, to the user institutions and awarded service providers. It would only be on receipt of such notification from the National Treasury that user institutions and service providers can affect any changes to this contract.
