RT302-2025 TRANSVERSAL CONTRACT CIRCULAR

TRANSVERSAL CONTRACT RT302-2025: SUPPLY AND DELIVERY OF SURGICAL SUTURES AND LIGATURES TO THE STATE FOR THE PERIOD 1 APRIL 2025 TO 31 MARCH 2030

1. PURPOSE

- 1.1. The purpose of this Contract Circular is to inform the relevant stakeholders concerning the award of the Transversal facilitated by the National Treasury for utilization by participating Organs of State regarding Contract RT302-2025: Supply and delivery of surgical sutures and ligatures to the state for the period ending 1 April 2025 to 31 March 2030.

2. TERMS AND CONDITIONS OF THE CONTRACT

- 2.1. This contract is subject to the General Conditions of Contract issued following Chapter 16A of the Treasury Regulations published in terms of the Public Finance Management Act, 1999 (Act 1 of 1999). The Special Conditions of Contract are supplementary to those of the General Conditions of Contract. Where the Special Conditions of Contract conflict with the General Conditions of Contract, the Special Conditions of Contract will prevail.
- 2.2. The National Treasury will communicate all amendments, if any, to the user institutions and awarded service providers. It would only be on receipt of such notification from the National Treasury that user institutions and service providers can affect any changes to this contract.
