RT57-2019: SUPPLY AND DELIVERY OF SEDAN, LIGHT AND HEAVY COMMERCIAL VEHICLES, BUSES, MOTORCYCLES, AGRICULTURAL TRACTORS, CONSTRUCTION PLANT AND EQUIPMENT TO THE STATE FOR THE PERIOD 1 JULY 2019 TO 30 JUNE 2023- TOYOTA SOUTH AFRICA RESOLUTION REGARDING THE OUTSTANDING DELIVERIES.

We refer to the above matter and the resolution of Toyota South Africa regarding the outstanding deliveries of the orders that were placed prior to the 30th of June 2023.

To all the participating institutions that placed orders with Toyota South Africa on the previous transversal contract RT57-2019 and are still waiting for the deliveries of such vehicles, please note that the resolution has been made and Toyota South Africa will deliver all the vehicles on the previous contract latest price and end-user should take note of paragraph 44.4 and 44.5 of the special conditions of contracts which state that:

44.4 Where the vehicle is delivered at a date later than the expiry date of the contract, the pricing of the vehicle as accepted on the new contract will be applicable. In the event that the vehicle is not accepted on the new contract, the last available contract price will be used.

44.5 The contract price shall be applied for the delivery period not exceeding a maximum of hundred and twenty (120) days. Should the maximum period be exceeded, the end user must either cancel the vehicle order or negotiate an adjusted price with the supplier.

All participating institutions are advised to liaise with Toyota South Africa and make necessary arrangements and agreements on how and when the orders will be delivered.

We trust that you will find this in order.
