3. From a financial accounting point of view, it is important to verify the correctness of the supplier's invoice for deliveries made in terms of the transversal contract. The participating institution should check for any discrepancies with the appropriate contractor before processing payment if there are any between invoice rates and the transversal contract price as stated in the contract circular. Payments made at rates other than those specified in the contract will be viewed as fruitless expenditure.
