## SUPPLY CHAIN MANAGEMENT: REQUEST FOR PUBLIC COMMENTS DRAFT PREFERENTIAL PROCUREMENT REGULATIONS, 2009 ALIGNED WITH THE AIMS OF THE BROAD-BASED BLACK ECONOMIC EMPOWERMENT ACT AND ITS RELATED STRATEGY

- The National Treasury in collaboration with the Department of Trade and Industry has compiled draft revised Preferential Procurement Regulations, 2009 aligning preferential procurement with the aims of the Broad-Based Black Economic Empowerment Act, 2003 and its related strategy.
- The Minister of Finance has approved that the draft Regulations be published in the Government Gazette and all the Provincial Gazettes for public comments. The draft Regulations together with the explanatory memorandum have been published in the Government Gazette and all the Provincial Gazettes dated 14 August 2009 with the due date for comments being 14 September 2009.
- A copy of the Government Gazette Number 32489 dated 14 August 2009 (General Notice 1103 of 2009) is forwarded to you with the invitation to provide any comments that you may have on the draft revised Regulations.
