The aim of the Department of Home Affairs is to protect and regulate the interests of the inhabitants of the Republic of South Africa, as individuals, in respect of their status, identity and specific rights and powers and to render a supporting service.

- ◆ Administration comprises financial management, personnel and provisioning administration, legal and other office support services and the formulation of policy by the Minister and management of the department.
- Services to citizens grants specified rights and powers to members of the population. It constitutes three main activities: travel and passport matters, citizenship matters, and population registration.
- *Migration* controls immigration according to South Africa's skills and investment needs and also controls visitors who enter the country on a temporary basis.
- Auxiliary and associated services renders support services to the Film and Publication Board and Film and Publications Review Board,

Government Printing Works, government motor transport, and the Independent Electoral Commission.

Refugee applications

By 2001/02, while the provision of identification documents will increase to about 8 million per year, the provision of passports and travel documents are expected to increase to about 1,5 million.

POLICY DEVELOPMENTS

New developments in the Department include:

- Opening of new offices in areas of previously disadvantaged communities.
- Setting up 89 service points apart from existing offices.
- Increasing the number of mobile units serving various centres in the country.

New identification system The Home Affairs National Identification System (HANIS) project is in the final stages of tendering. HANIS is aimed at automating the present manual fingerprint identification system; substituting the identity document with an identity card; and integrating two systems with the existing population register. The overall cost of the project is estimated at R800 million over an 8-year period.

Migration The Ministers' Forum of the National Crime Prevention Strategy identified effective border control as a measure to cut crime and trade abuse. The Department, SARS and SAPS are co-operating to improve control at the border posts. 51 ports of entry are already linked to the movement control system which facilitates communication between the national, regional and district offices and border posts. The Migration Task Group, which is charged with developing a new and effective migration policy, has also started its work.

A computerised visa system has been instituted to curb the forgery of South African visas. The system is being expanded to all South African missions abroad and is due for completion in five years.

The Department is also revising existing legislation to comply with the Constitution: the Identification Act of 1986; the SA Citizenship Act of 1995; the Deaths and Births Registrations Act of 1992; and the Aliens Control Act of 1991.

The *Services to citizens* programme includes issuing of passports and other travel documents; the repatriation of, and financial assistance to, RSA citizens abroad who have financial problems; the determination, granting and forfeiture of RSA citizenship; and the processing of applications of work, study and temporary residence.

Migration includes maintaining a population register of South African citizens and of foreigners who have acquired the right to permanent residence in the RSA; handling of migration matters in foreign countries; controlling the admission of travellers at ports of entry and visas; deportation of illegal aliens; and considering and processing refugee affairs.

The programme also provides for remuneration and allowances to members of the Immigrants Selection Board and Regional Committees. The programme is composed of five main activities:

- Consular affairs for handling of migration matters in foreign countries.
- Permanent and temporary residence.
- Immigrants Selection Board and Committees.
- Control of travellers.
- Control of foreigners entering the RSA.

The Auxiliary and associated services programme is responsible for:

- Provision of the funding of the Independent Electoral Commission.
- Provision of grants-in-aid to the Consultative Committee for Performing Artists.
- Augmentation of the Government Printing Works Trading Account for the printing and supply of stationery to government departments as well as the provision of government publications for sale to the public.
- Classification of certain films and publications.

COMMISSIONS, FUNDS AND ACCOUNTS

Independent Electoral Commission

The Independent Electoral Commission (IEC) was established in terms of the Electoral Commission Act of 1996. The IEC is an agency established to manage elections for national, provincial and local legislative bodies and referenda and providing for the establishment of an Electoral Court. The IEC receives its funding from the vote Home Affairs and the amount allowed for the 1999/00 budget is R722 million. The funds are required by the Commission to establish a national voters role and for the management of the general elections that will take place during mid-1999.

Government Printing Works Trading Account

Purpose and functions

The Government Printing Works provides for the printing, stationery and related requirements of government departments, provincial governments

and local authorities, and publishes, markets and distributes government publications.

Apart from the above-mentioned functions, the Government Printing Works provides a variety of related services to departments, the printing industry and other African countries, for example, the manufacturing and supply of fingerprint ink to the South African Police Service as well as specialised items such as postage stamps to the Democratic Republic of Congo and the Kingdom of Lesotho.

There was a substantial decrease in the total quantity of orders for printed matter from 1996/97 to 1997/98.

Government publications During 1997/98, the demand for government publications, maps and Official Gazettes showed an increase in revenue, to R26,4 million compared to R22,7 million in the previous year. An amount of R2,2 million was paid to the National Revenue Account as profit on the trading account.

An increase in the number of Government Gazette editions occurred resulting in 985 editions being published as opposed to 858 editions for the previous year.

The role of the private sector The private sector, as in the past, was extensively involved in the supply of printed matter for government purposes. There has been an increase of approximately 21 per cent in the value of orders subcontracted compared to the previous year. Small, medium and micro enterprises have shown great interest in tendering for printing jobs and were awarded some of these were subcontracts.

The value of printing work contracted out to the private sector has increased from R46,8 million in 1995/96 to R69 million in 1997/98.

Government PrintingThere has been a substantial decrease in the printing requirements from
the Umtata Government Printing Works from 868 in 1997/98 to 365 in
1998/99.

A provincial printing facility was opened in Bisho in November 1998, providing stationery and publishing items for departments and government institutions within the province.
