1. OVERVIEW

Vision

The vision of the Department of Transport, Roads and Works is:

to be trendsetters through excellence in service delivery.

Mission and strategic Goals

The vision will be supported by the mission to:

- Ensure a safe transport system;
- Meet the accommodation needs of the provincial Departments;
- Contribute to the empowerment and development of communities; and
- Optimise the department's managerial process

The vision and mission will be realised through promotion of the **strategic goals** of the department:

1. Commitment by the Ministry and Department to national and provincial policies;
2. Develop a competent and motivated workforce;
3. Develop and maintain a fully integrated communication strategy with the public, clients and officials in the department;
4. Provide and maintain a transport network, road safety network and road infrastructure which are safe and functional, to support social and economic development;
5. Promote road safety and law enforcement
6. Provide and maintain functional accessible buildings and accommodation according to the identified needs of clients and ensure the planning and design of safe and cost-effective projects and buildings for client departments;

7. Support the sustainable development of historically disadvantaged entities with the emphasis on poverty relief in the Northern Cape through the Community Based Public Works Program and the Emerging Contractors Development Program;
8. Promote zero tolerance of corrupt practices, and ensure compliance with all relating legislation, management policies, processes and procedures;
9. Improve the financial management processes to ensure accountability
10. Develop an integrated human resource strategy
11. Implement the computerized government systems for managing and controlling movable assets
12. Continuously benchmark the internal functions and performance outputs against best practices.

2. REVIEW OF THE CURRENT FINANCIAL YEAR

Infrastructural and other Studies done for Economic Revival of the Province

The Department commissioned the following studies to be done in the last financial year:

Usage of Airport and Air travel in the Province

The aim of this study was to determine the current usage of our Airports and also to determine ways of reviving air travel within the province for tourism and other purposes.

Toll Roads Strategy

The aim of this study is to determine ways of constructing toll roads in the province and the positive spin-offs that could be experienced should it be implemented.

Port Nolloth Harbour Study

The aim of this study is to determine the feasibility of establishing a deep sea Harbour in Port Nolloth. This study is carried out with the background of limited economic activity in the Namaqua area, which is mainly carried by a diminishing diamond mining industry.

New Office Block

The aim of this study was to investigate the status regarding Government office accommodation in terms of costs and accessibility to the public.

Among other things the report found that the money that government currently spends on leases far outweighs the costs if government was to build its own office block; Nearly 80% of government offices is leased from the private sector; escalation of rentals of these offices is not market related.

As a result of this study the department is in the process of entering into a Public Private Partnership (PPP) to accommodate all Departments who are leasing office space.

Training and development

- √ 20 Middle management staff was sent on a supervisory course during the 2002/2003 financial year.
- √ All the level 9 to 13 attended the Integrated implementation Program sponsored by the European Union and offered through Wits University.
- √ Most of the finance staff attended the Internal audit, Financial accounting and Management accounting course provided by Technikon SA.
- √ All these courses mentioned above are accredited by SAQA

ROADS

The Departmental construction team built the Delportshoop intersection successfully at a cost of R490,000.

The rehabilitation of roads in the area of Phillipstown started in January 2003 an estimated cost of R1.5 million will be spend this financial year, and this job will done be done by the departmental team of road workers.

"Asbestos" roads project

There are a number of roads in the Northern Cape which are contaminated with asbestos fibres, chiefly roads serving the asbestos mines in the Kuruman area. R1 300 000 was made available to construct a pilot project in which various rehabilitation techniques have been applied. This project was substantially complete by the end of December 2003. Unfortunately rains have affected one section which will have to be re-done. After completion the sections will be monitored for asbestos dust and general condition before proceeding further.

Periodic Maintenance

- The rehabilitation of the N10 in the De Aar area has started and. R17 million was spent in 2002/2003.
- The project: *Calvinia Bridges* was completed successfully at a cost of R1.7million.
- Consultants were appointed for the design of the rehabilitation of TR16/3 (Nieuwoudtville - Calvinia).
Construction of this project will start during the 2003/2004 financial year.
- The process of the re-arrangement of Departmental work teams was completed with periodic maintenance and other teams to follow shortly.
- All the resealing for the current financial year was contracted out.

TRAFFIC CONTROL

ARRIVE ALIVE CAMPAIGN

Fatalities increased in the current financial year compared to the previous year. Most of the fatalities occurred in on the municipal roads, which means more emphasis should be placed in municipal areas instead of the National roads.

A joint operation with the local authorities in the province was held and the following summary was formulated:

Road Safety projects

- The Department participated in the National Driver of the competition
- a pilot project of plant a seed was undertaken on two schools in Kimberley with the focus creating awareness on road safety.
- There were 3 new scholar patrol crossings were registered from April 2002 until December 2002.

- A number of exhibitions were held in the Province with the main focus on road safety and pedestrian safety.

WORKS

The policy on the (ECDP) emerging contractor development programme for the department has been approved by the MEC. Help desks for the emerging contractors will be situated in the Regional Offices in Upington and Kimberley. The officials involved in this section will be given training and the database will be based on the National Department of Public Works Sakhasonke programme.

The work of building, upgrading and maintaining provincial government buildings has to a greater extent been carried out in terms of the public works programme. More than 80 percent of maintenance work which went out on quotation and tender was awarded to SMME's.

REVENUE

The department implemented initiations to ensure that all revenue due to the Province is received on time and in full:

- Compelling authorities to pay over all monies (including the revenue they are entitled to) on a daily basis.
- Retaining the agency fees due to the authorities a part payment on the arrear fees.

It is predicted, based on average monthly income, that 98% of the projected R48.8 m will be raised by the end of the current financial year.

Job Creation project

- Sedibeng Consulting Engineers was appointed by the department for the R12M job creation project while the Directorate: Roads funded the road marking teams, routine maintenance teams and the ladies employed to maintain the rest areas.

- Routine maintenance will continue in spite of the ever increasing cost battle and the declining budget.
- Maintain the road management systems to a high standard, to inform management and to properly prioritize maintenance and rehabilitation actions.
- Allocating ±7% of the budget for job creation and to create 15% more jobs next year.
- As the current road network is deteriorating, rehabilitation and resealing will take precedence over the construction of new roads. Only the Kommagas road will be upgraded to a surfaced road and then Sutherland road will be upgraded to an all weather surface.

TRAFFIC

The Department will, as part of its vigorous law enforcement programme adopt a zero tolerance campaign as far as road safety and traffic law enforcement is concerned. This zero tolerance programme will be supported by programmes designed to educate the public on road safety issues and to involve them in road safety campaigns. This includes the Safety in Traffic Educational Programme, which is a programme presented at pre-school level. This is followed by the Child in traffic programme for primary schools and the Scholar Patrol programme from grade five up to grade eight. The Department also runs an ABET programme in Traffic with the support from the Department of Education.

- Road safety education will continue to be viewed as a priority programme, with the focus on the public transport sector and schools
- The Provincial Traffic Department will continue with its joint operations with other law enforcement agencies (SAPS, SANDP, Local authorities) specifically focusing on both vehicles and driver fitness.

LAND TRANSPORT

Include the regulation of the taxi industry, as well as the management of the National Department of Transport bus subsidy programme.

The implementation of remaining sections of the National Land Transport Transitional Act will be the priority during this year. This will include the finalisation of Registration, Conversion of Permits, establishment of Transport/ Planning Authorities at Local Government level, and the implementation of the various planning guidelines and requirements in conjunction with Planning Authorities.

4. REVENUE AND FINANCING

A total of 151 567 vehicles are registered within the Province. The expected revenue for 2003/2004 will thus increase from R54 m to R55,224m.
