

FOREWORD

**Honourable Premier,
Members of the Provincial Legislature,
People of the Eastern Cape Province and the rest
of South Africa

The Provincial Government of the Eastern Cape and its social partners have formulated a Provincial Growth and Development Plan (PGDP), in line with national policy framework for socio-economic planning at provincial level. The PGDP has provided the strategic framework, sectoral strategies and programmes aimed at a rapid rural improvement in the quality of life of the poorest people of the Province. This new Strategic Framework is a product of joint deliberations by all stakeholders and constitutes a consensus position on our growth and development path for the next ten years.

The ten year Provincial Growth and Development Plan (2004 – 2010), therefore places strong emphasis on rural growth and development as this is where the most severe poverty lies. It is in this context that projects and programmes were set out in three main documents:

- The PGDP Strategic Framework adopted by the Provincial Cabinet in June 2003.
- The PGDP Priority Programme Intervention adopted by the Budget Indibano on the 8th August 2003 as the framework for prioritising provincial resources for the forth coming MTEF period 2004/05 to 2006/07
- A review of provincial department Strategic Plans presented by departments to reflect PGDP priority programmes and projects that they could implement during the new MTEF period.

The strategic framework sets out the following six strategic objectives, with poverty eradication as an overall strategic goal for the plan:

- Poverty eradication
- Agrarian transformation and household food security
- Manufacturing growth and diversification and tourism development
- Human Resource Development
- Infrastructure Development
- Public Sector Transformation

It is these key areas that our departments will particularly seek to address in the 2004/05 financial year. In pursuance of these departmental objectives, this budget statement outlines our spending plans for the various programmes and allocation of resources to spending agencies.

As part of the budget reforms that we continue to pursue, I do hope that this budget submission will go a long way in enhancing our understanding and debate about our budget.
