## 1. OVERVIEW

## **Statement by the MEC**

The present year will be characterized by priorities such as an intensive infrastructure development with special emphasis on provision of sanitation facilities, water and maintenance of existing infrastructure. Step-up supply and delivery of learner & teacher support material to all schools, especially Grade 12. Declare mathematics and science an emergency. Improve the processes of effective management of the primary schools nutrition as well as increasing delivery rates in schools.

#### Statement by the Accounting Officer

I, as Accounting Officer, am committed to the implementation of the budget for the 2005/06 financial year to address the priorities as indicated by the Executive Authority as reflected above.

#### Vision

An Education Department that is accountable and accessible to all, rendering a sustainable and quality service, promoting lifelong learning opportunities and people's self-reliance while continually contributing towards a democratic society and economic growth.

#### **Mission**

The department finds it's vested authority and character in the overall objective of the South African Schools Act, 1996, Act 84 of 1996, which is to provide quality education which is accessible to all, relevant and cost effective, within the principles of equity, redress and affordability, after taking full account of the applicable policy determined in terms of the National Policy Act, 1996, Act 27 of 1996.

## **Core Functions**

- To achieve equal educational opportunities for all learners;
- To assist the learner to achieve complete realisation of his/her full potential through scientific, modern and innovative education and professional guidance; and
- To achieve an overall education of the learner which will serve the interests and the development of the country and of the community.

- To break the back of illiteracy among adults and youths by 2005;
- To make schools centres of community life;
- To end conditions of physical degradation in South African and especially North West Province's schools;
- To develop the professional quality of our teaching force;
- To ensure the success of active learning through outcomes-based education;
- To create a vibrant further education and training system to equip youths and adults to meet the social and economic needs of the 21<sup>st</sup> century;
- To deal urgently and purposefully with the HIV/AIDS emergency in and through the education system

## Demand for and changes in services of the department

In 2005/06 financial year, the following services are in demand, and the department intends doing the following about them:

- The department will continue to fully operate under the new organizational structure, meaning that regions will be the focal points of service delivery, and schools will benefit more from the decentralized nature of the structure.
- There is an urgent need to grant all our schools Section 21 status. This will give more accountability to schools, and it
  will make procurement of resources relatively easier. This means regional offices will monitor schools strictly on how
  they spend their budgets.
- Special school education needs more education therapists and an improvement in infrastructure necessary for supporting learners with severe learning disabilities. The approved posts for these specialists need to filled urgently in the new financial year.
- The National Department of Education demands a 5% enrolment increase in FET institutions. Our thrust will be to offer a market-related curriculum as one way of attracting students to enroll in these Colleges.
- There is an increase in learners doing grade 10-12 in ABET centers. The thrust this year is to encourage such individuals to register in FET Colleges and do only a limited number of subjects with ABET. Or ABET centers should begin to offer skills programmes for such individuals.

- The new curriculum stipulates that the Foundation Phase starts from Grade R to Grade 3, yet some of our primary schools do not offer Grade R. This year, the focus will be on assessing the viability of the current registered ECD centers that are offering Grade R, so as to link them up with neighbouring primary schools that are currently not offering grade R.
- The department has taken over the PSNP project from the health department, hence, personnel must be appointed and systems must be put in place to manage and sustain this project in order to feed the hungry North West school children.

## 2. REVIEW OF THE CURRENT BUDGET YEAR

- The department established the five regional offices successfully.
- The department managed to fill the crucial vacancies within the new approved structure.
- The project to decentralize human resource and salary administration functions to regions is proceeding satisfactorily. Related risks are reasonably managed and we remain optimistic that we will achieve the goals we set for ourselves within target dates.
- Access to schools by our Institutional Support Coordinators (ISC's) is strengthened and supported through our plans to provided +/- 100 vehicles to these and other officials supporting schools.
- The department trained more school governance structures and school management and has increased the number of section 21 schools.
- Rendered support to all schools to obtain an improved matric pass rate.
- The 100 days of service delivery yielded the following outputs:
  - Under the sanitation programme, 1058 toilet seats were erected in 66 schools.
  - The first phase of Onkgopotse Tiro Comprehensive School was completed during the period under review
  - 80% of work has been completed in the phase II of the Capex Project in 11 schools.
  - Painting of 52 schools to the tune of R500 000 is in progress

#### **CHALLENGES**

- Demographic changes have a negative impact on schooling in general
- · Access to disability grants impacts negatively on disabled learners who need hostel accommodation
- Mainstreaming special schools will have an impact on the budget, infrastructural changes and human resources in public ordinary schools
- Access to FET institutions by youth who cannot afford to pay for programmes offered is a challenge
- FET institutions have to deal with literacy levels ranging from poor to good
- · Access to FET institutions by rural communities is a challenge because most of these Colleges are in urban areas
- Degradation of ECD centres due to poverty and unemployment
- Orphaned children due to HIV/AIDS have difficulty accessing ECD services
- Demographic changes affect rural communities (lead to low enrolments)
- Poverty and unemployment in the province is a threat
- Primary School Nutrition Programme payments to suppliers
