





#### **OFFICIAL NOTICE 8 OF 2008**

#### NORTH WEST DEPARTMENT OF FINANCE

ALLOCATION, OTHER THAN AN ALLOCATION NOT INCLUDED IN ANY SCHEDULE OF THE DIVISION OF REVENUE BILL, 2008 (BILL NO.4 OF 2008)

Notice is hereby given that the Provincial Accounting Officer in the Department of Developmental Local Government and Housing and Department of Sports, Arts and Culture intends to make allocations as per attached Schedules, in terms of Section 31 of the Division of Revenue Bill, 2008 (Bill 4 of 2008); to the Municipalities.

The following schedules are published in terms of section 31(2)(a) of the Division of Revenue Bill No.4 of 2008, which stipulates that "The Provincial Treasury must in respect of allocations to municipalities other than allocations made in terms of the Division of Revenue Bill No.4 of 2008, publish with its budget and in the Gazette" such information.

# ALLOCATION, OTHER THAN AN ALLOCATION NOT LISTED IN ANY SCHEDULE OF THE DIVISION OF REVENUE BILL OF 2008

Furthermore, any transfer of an allocation aimed at developing municipal systems and the capacity of municipalities to perform functions assigned to them, may only be made in terms of a framework determined by the National Accounting Officer responsible for Local Government, in consultation with the National Treasury." In terms of operational plan for the delegations to Provincial Treasuries according to MFMA by National Treasury, the revised gazette must be done around January each year to allow municipalities to include that information on their budgets to be tabled to the councils.

Section 31 (5) (a) (iii) Division of revenue bill no. 4 Of 2008, Provincial Treasury as part of consolidated report in terms of section 32 of the Public Finance Management Act, in the format determined by the National Treasury, report on actual transfers made by the province to municipalities, and actual expenditure by municipalities by on such allocations.

The transferring department must disclose on their annual report for any capacity-building allocation and indicate the extent to which the capacity was improved.
