2. Review of the current financial year (2020/21)

Performance Highlights for Financial Year 2020/21

The creation of jobs is at the centre of the DESTEA economic agenda, and it remained a major priority during 2020, despite the challenges emanating from the COVID-19 pandemic. The interventions planned by Free State Provincial Government are meant to bring about meaningful and long-lasting solutions to challenges facing the Free State economy. These interventions are a bold and yet achievable expression of intent towards a transformed economy and a prosperous society that is living in harmony with its natural resources.

Support to Small, Micro, Medium Enterprises Through Various Support Initiatives

2.1.1 Enterprise Incentive Schemes

The department introduced three enterprise support incentives as part of its Covid19 relief initiatives:

- (i) Enterprise Support Incentive: targets small enterprises in key sectors such as retail, manufacturing, tourism, agro-processing
- (ii) Risk-Sharing Incentive: targets medium to big enterprises for expansion purposes
- (iii) Informal Sector Incentives: Targets Hawkers and tuck shop owners with the provision of grants for purchasing of stock.

The 2118 complete applications were received for 2020/21 DESTEA Incentives. And a total of 681 enterprises, mostly in townships, were assisted with funding to the value of R61m.

In addition to these, two salt mining cooperatives (Soutpan and Petrusburg) have been funded and three additional mining applications have been lodged for approval. This part

of the drive to ensure broader participation in mining activities in the province by emerging SMEs.

2.2 ACCESS TO MARKETS

The department has embarked on utilizing various platforms such as newspapers, social media and broadcasting platforms to expose the SMMEs for access to markets.

- **Procurement Opportunities**

A draft provincial procurement framework has been developed by the department in conjunction with Provincial Treasury, which is aimed at focusing provincial procurement so as to benefit SMME's and youth in the province.

The FDC has established a primary agriculture cluster in Lejweleputswa. The purpose of the cluster is to ensure that SMME become part of the value chain of production, supply of products through collaboration between SMMEs and Corporate Businesses.

2.3 Shared Economic Infrastructure Facilities (SMME Hubs)

The Koffiefontein Hub is in an advanced stage of planning with interest expressed by FDC, CELL C, PAULIDA, PEDRA DIAMOND, DESTEA, SEDA and LETSEMENG. The hub will be launched in the 2021/22 financial year. The Ficksburg SMME hub, which will accommodate about 35 SMMEs, has also been completed and will be handed over to the municipality before the end of February 2021.

Botshabelo ICT Hub

Establishment of the ICT hub in Botshabelo is in the finalization process of its operationalization. The hub will initially incubate 30 young people from Thaba-Nchu, Botshabelo and Bloemfontein. The Botshabelo digital hub is a government initiative established by a collaboration between the Small Enterprise Development Agency (SEDA), Softstart Business and Technology Incubator (SBTI), Mangaung Metro, Free State Development Corporation (FDC) and the Department of Trade, industry and Competition (the dtic) which aims to provide a platform for communities, particularly the youth and innovators in general to collaborate and develop digital technologies that will be locally relevant but globally competitive, all this linked with the Fourth industrial revolution. This is a state of the art facility where various activities will be taking place such as hackathons, coding, gaming, robotics, 3d printing, etc. The innovators will be supported throughout their innovation development journey from ideation until commercialization with facilities and business development services.

The criteria to be used to select participants for the digital is as follows: The digital hub is targeting existing and aspiring innovators with innovative business ideas, which are:

- Technically viable
- Market feasible
- Commercially viable

Furthermore, as means of gearing communities towards the Fourth industrial revolution (4iR) the hub will also implement regular outreach programmes in communities with the aim to bridge the digital divide and capacitate them with digital skills so as to create a strong

pipeline of future innovators. The Hub will also collaborate with other role-players in the innovation and entrepreneurship ecosystem both in the private, public, NGO and academia both in the Free State Province and beyond.

TRADE AND INVESTMENT PROMOTION

2.5.1 Trade and Investment Portal

In order to enhance investment attraction, DESTEA has subscribed to the online Free State Business hosted by the Global Network Group. This portal is intended to profile and market investment opportunities available in the Free State province and to position the province as an investment destination of choice.

2.5.2 Industrial Park Revitalization Programme

The programme is funded by the DTIC and phase one of the industrial park upgrades has been completed in Botshabelo and Phuthaditjhaba. The Second phase of Botshabelo industrial park revitalization is 75% completed and will be completed in May 2021. This revitalization has created 90 direct jobs. Revitalization enhances security and infrastructure of the industrial park which attract more investors into the Industrial Park. The Botshabelo Shelter is in an advanced stage of development; this facility will create over 1500 jobs in and around Botshabelo when completed and fully operational.

2.5.3 MAPSEZ Investment

R1.1 billion of new investments have been secured in the MAPSEZ, via various companies. These companies will create 466 new jobs once fully operational. In addition, another R3.2 billion of investments are in the investment pipeline, which will support another 218 new jobs (Eggnificent (Pty) Ltd, Afri-Starch, Lightfield E-Pharm, Toresh/Molend Engineering).

Environmental Management and Conservation

2.6.1 Waste management

The portable waste management project is on its last financial year of support and implementation and is benefitting 91 young Waste Recycling Entrepreneurs across the province.

2.6.2 Good Green Deeds programme Good Green Deeds programme: 227 work opportunities created in the following towns: Memel (25), Theunissen (25), Winburg(25), Verkeerdevlei (25), Ladybrand (30), Jagersfontein (20), Trompsburg (25) Schools (50), Park (2)

2.6.3 Black Game Ranchers Programme

The Black Game Ranchers programme is aimed at transforming the wildlife industry by ensuring that blacks, particularly women and youth, gain a foothold in the industry. To this end, the department has finalized the process to donate various game species to 40 Black Game ranchers and these will be delivered as soon as the approval of the legislature has been obtained.

Consumer Protection and Business Regulation

2.7 Compliance Inspection initiatives:

Inspection Operations from April to November – 2020:

- 87 Towns visited
- 756 business operation subjected to Operations
- 48 Arrests (undocumented migrants, human trafficking, fraud)
- 708 Infringements in terms of the Consumer Protection Act

2.8 Other Interventions and Highlights

- More than 21 000 home-based sanitizers distributed to households across the province in response to the Covid-19 pandemic.
- 190 EPWP jobs were created across the resorts and nature reserves managed by the department. These are in areas such as cashiers, hospitality services, and alien vegetation control.
- DESTEA has collaborated with Standard Bank in the 'YES for Youth Programme' by placing 60 unemployed graduates with different DESTEA-supported SMMES for internship and support of the SMMEs with various skills; this programme will be expanded in the next financial year.

- Compensation of Employees:** The allocation is R287.492 million for 2021/22 and R290.399 million for 2022/23 and R297.181 million for 2023/24. No Salary adjustments are expected over MTEF period
- Goods and Services:** The allocation for 2020/21 is R123.329 million and in 2021/22 is R131.758 an increase of R8.429, this is due to a reduction in the allocations for transfers to private enterprises and funds are now under Goods and Services.
- Transfers and Subsidies:** For 2020/21 an amount of R199.840 million was allocated and was reduced to R152.507 million in 2021/22 and the reduced allocation is due reduction in allocation to private enterprises.
- Building and Other Fixed Structures:** The department has decided to focus on finalising the Sandveld Project has allocated R77 million over the MTEF to complete the project.
- Machinery and Equipment:** The allocation under machinery and Equipment is mainly for the procurement of computers and equipment for resorts and reserves.

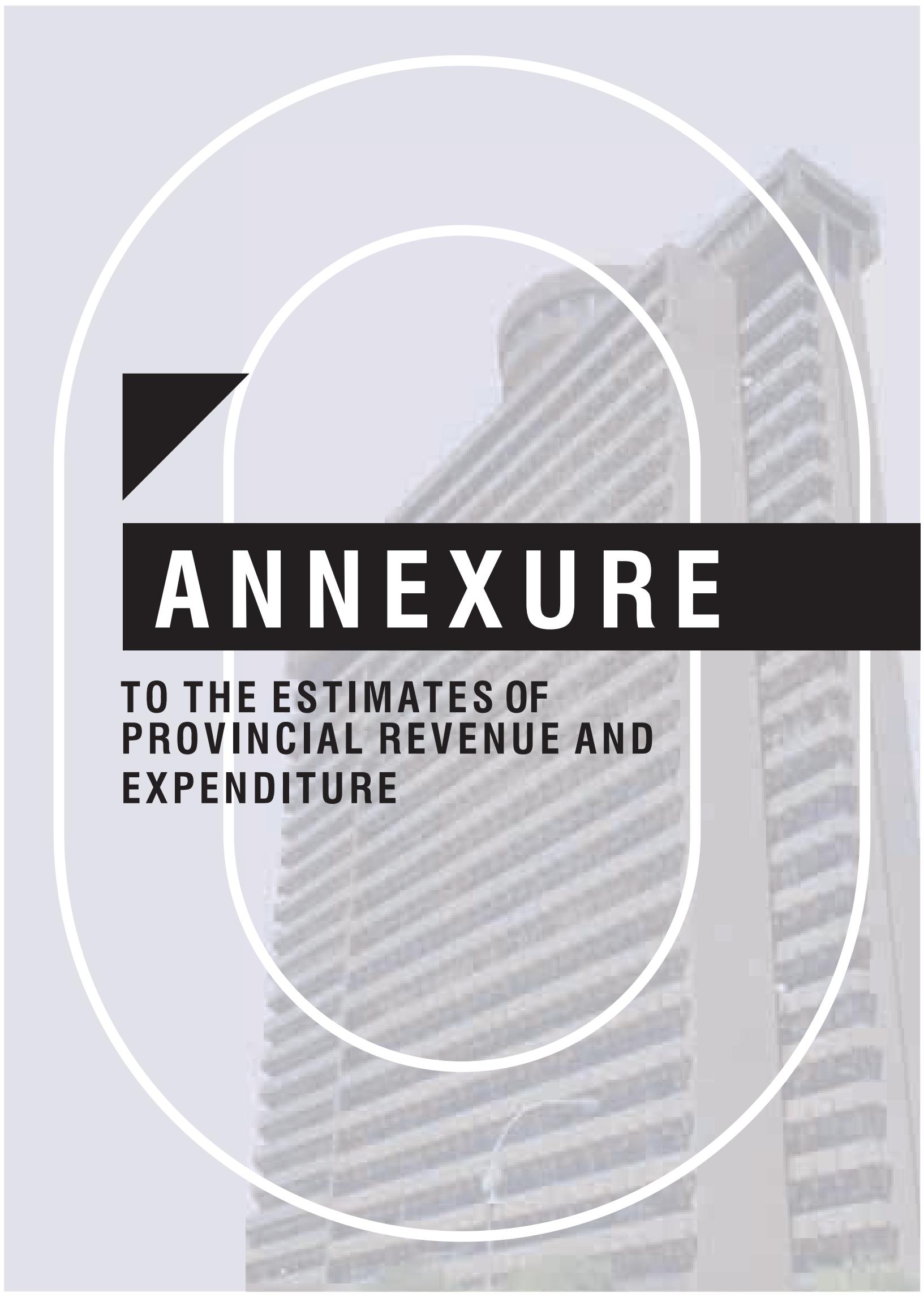
