#### 1. Overview

#### **Vision**

Building a united prosperous society in the NW Province.

#### Mission

The North West Provincial Legislature (NWPL) aims to provide services to the people of the North West province by ensuring:

- 1. A vibrant Legislature that is responsive to the challenges of development facing our people;
- 2. An accountable Executive and other Organs of the State by strengthening oversight on the promises made to our people by Government;
- 3. Promotion of efficient and healthy intergovernmental relations between the three spheres of government; and
- 4. A creative, effective, efficient and transformative administration that helps the Members of the Legislature to fulfil their constitutional mandate.

### **Organisational Values**

In striving for service excellence and best practice, the administration subscribes to the following core values:

Integrity : Being honourable and following ethical principles.

Responsiveness : Responding to the needs of the people of the Province.

Transparency : Transparent, being open and accountable in its operations and records.

Trustworthy : Building trust with the people of the Province.

Professionalism : Efficiency of operations, informed decision-making and a general professional

attitude by providing advice and services of a high quality.

#### **Mandate**

The North West Provincial Legislature's mandate is derived from the Constitution of the Republic of South Africa (Section 104). Members of the Provincial Legislature (MPLs) are elected to represent the people and the constitutional mandate is to ensure Government by the People. The core function of the Legislature is to pass laws for the North West Province, to conduct oversight over the Executive and other Organs of State and to promote public participation.

## Strategic goals

The Provincial Legislature has the following four strategic goals:

- To effectively and efficiently conduct oversight over the Executive, so that it is held accountable and delivers on its mandate:
- To enhance the policy and legislative capacity of the Legislature in order to pass transformative legislation;
- To promote good corporate governance;
- To enhance public awareness and effective participation of the public and stakeholders in the Legislature's activities and business

#### Core functions of the Legislature

In order to achieve the above strategic goals, the North West Provincial Legislature (NWPL) is responsible for carrying out the following core functions:

- To make laws for the province. Essentially, this means that the North West Provincial Legislature has a duty to improve the quality of life for the people of North West Province by creating laws that are just and responsive to the people's needs.
- To provide support to Committees and the Institution by ensuring public participation in all its programmes.
- To oversee the provincial government it is the North West Provincial Legislature's duty to ensure that the government of North West uses its authority in a responsible manner, and that it implements the province's legislation in the best interest of the people of this province.

### 1.1 Aligning departmental budgets to achieve government's prescribed outcomes

All fourteen outcomes are relevant to the North West Provincial Legislature (NWPL) in that the Legislature is responsible for the execution of the oversight function over the executive and other organs of state. The role of the Legislature is therefore to ensure through its mandate as outlined in the constitution that departments and organs of state adhere to the implementation of the outcome-based approach.

### 2. Review of the Current Financial Year (2020/21)

### **Public Participation and Oversight**

The emergence of the pandemic led to the Legislature amending the manner in which it conducted its business, in the sense that Portfolio and Standing Committees could not freely interact with members

of the public due to Lockdown restrictions. This placed a strain on two mandates of the Legislature, namely Oversight and Public Participation.

The recent dynamics meant that the Legislature needed to pave some new and innovative strategies in conducting its business during the lockdown period to comply with the regulations and still meet its intended objectives and outcomes. A political directive was issued indicating the prioritisation of activities, which are directly linked to the legislative oversight and state institutional compliance documents.

The Legislature was not exempted from adapting to new normal by turning towards technological solutions such as virtual and hybrid platforms as well as an enhancement of social media platforms i.e. broadcasting through YouTube channel and Facebook page.

Notwithstanding the above, Great progress has been registered in addressing the issues raised by the Inter-Ministerial Task Team regarding the Section 100 Intervention. It was stated that governance, financial management and audit results of different departments had improved since the national government intervention.

### Oracle System stabilization - Phase II

The Legislature has successfully completed Phase I of the Oracle Stabilization project, which serves as a base for Phase II project planning. The most critical element of the close out report for Phase I was the lessons learned from implementation of Phase I.

The commencement of Phase II was planned to commence during the second quarter of the financial year, however this was not realized due to lockdown restrictions which imposed limitations on interprovincial travelling as well as face-to-face contact engagements. The delay was further exacerbated by the industrial action by the majority union within the NWPL. As a result, the allocation of resources (personnel) could not be concluded due to uncertainties around the length or duration of the strike. Despite the challenges as outlined, the NWPL managed to convene Steering Committee meetings to commence work on the strategic documents including strategic decision making around the project planning and implementation.

To this end, the NWPL has concluded the Project charter, which serves as a roadmap towards successful achievement of deliverables as intended by the project. The NWPL has continued to implementation and configuration of modules that are critical for governance efficiencies and ensuring optimum utilization of the Oracle system.

The new modules include but not limited to the Compensation Workbench which entails governance and integration of HRM and Payroll functionalities; Performance Management module – for optimum

and electronic performance management; Cash management module to enhance real-time automated reconciliation.

#### Infrastructure

The refurbishment of the chamber has been halted with funding being reduced and redirected towards aiding the pressures on the national and provincial fiscal framework. The allocation has been revised downwards to R20 million in the 2021/22 financial year to cater for the ICT infrastructure/systems that are not affected or will not be affected by the construction phase when the project is resuscitated.

The National Key point Project is still at pre-tender stages and commencement of construction is anticipated in the 2021/22 financial year.

### 3. Outlook for the coming financial year (2021/22)

For the 2021 - 2022 financial year, the Legislature plans to develop and implement various electronic systems to expedite the work of the Standing and Portfolio Committees. The electronic systems shall be amongst others, the Tracking and Monitoring of House Resolutions and the Petitions Tracking System.

Utilisation of these electronic systems will lead towards strengthening the oversight activities conducted by Members of the Provincial Legislature

### **Increased Public Awareness and Participation**

The 2020/21 financial year proved that virtual and hybrid meetings as well as social media are the future and the institution shall continue relying on and utilising these methods for the 2021/22 financial year. However, these methods are not always optimal considering the limited ICT resources in disposal of many communities across the province.

The Legislature will conduct oversight over the North West Provincial Departments to ensure that the National Priorities, namely; defeating the coronavirus pandemic, accelerating the economy recovery, implementing economic reforms to create sustainable jobs and drive inclusive growth as well as fighting corruption. These find expression within the Annual Performance Plans for the 2021 – 2022 financial year.

Additional oversight tools and templates will be developed to aid MPLs in performing their duties to get to the crux of challenges departments may be experiencing with the goal to better the lives of the people.

Through the public participation programmes members of the public are engaged and areas of concern are noted. These concerns are elevated to the respective Provincial Departments and progress thereon

is monitored through the House Resolutions. This year emphasis will be placed on more public involvement in Legislature activities.

Through the education programmes, community members will also be informed of the various methods of interaction with the Legislature (Sectoral Parliaments, Public Hearings, the Speaker's Programmes, etc.) and how to utilise the Petition System. The new Public Participation Strategy will guide us in ensuring that the needs of the public are heard and taken cognisance of.

The need for expert legal opinions on the status of the current NW Petitions Act remains whilst the institution develops guidelines and procedures to assist in the processing of petitions.

The NWPL will conduct 33 public participation programmes in 2021/22, then increase to 48 then 88 over the two outer years. The number of public participation programmes have significantly revised downwards in observation of the Lockdown restrictions.

### **Enhancing Oversight**

The Section 100 Intervention will continue until June 2021, with the Task Team citing their reasons that critical vacancies had to be filled. Through rigorous oversight and holding the Executives accountable, the aim is to ensure that the departments implement the recommendations issued by the Task Team. This could expedite the withdrawal of the Section 100 Intervention and prevent the recurrence thereof.

The outcome of the Auditor General (AG) audits on the provincial departments are also taken into cognisance. The aforementioned documents and speeches serve as a guide to plan amongst others, the oversight duties. Included in the oversight will be amongst others, programmes/activities that were noted in the State of the Province Address (SOPA). These are, the roll-out of the COVID-19 vaccinations, addressing the accruals within the provincial departments and the implementation of the Social Relief of Distress Programme, to name but a few.

The NWPL's plans to enhance oversight is evidenced by the increase on the number of Committee reports to be tabled from 171 in the current financial year to 200, 261 and 290 respectively over the medium term.

### **Strengthening Law-making Practices**

The Legislature is tasked with making laws for the province and has a duty to improve the quality of life for the people of the province by creating laws that are just and responsive to the needs of the people.

One of the current areas of concern within the institution is the technical legal expertise required to support Members of the Legislature regarding the drafting of Bills. With the implementation of the newly approved organogram, the Legislature aims to fill this gap by appointing those that possess the necessary skills and expertise to do so.

### **Monitoring House Resolutions**

One of the mandates of the Legislature is to hold the Executive accountable. This is achieved through various oversight Committee meetings whereby Provincial Department Heads are called to account on subjects such as service delivery and the utilisation of public funds.

Where discrepancies or irregularities are noted, Committee recommendations are issued to rectify the matter. However, the implementation of such recommendations are tedious and at times not implemented at all. The Committee recommendations are not binding as the Standing Rules of the Legislature has not made provision for this, as a result department are able to ignore Committee recommendations without any consequences.

With the implementation of the e-Parliament System, the Legislature will be able to monitor the House Resolutions electronically. However, prior to utilising the electronic system, a Standard Operating Procedure (SOP) manual for the recording and monitoring of House Resolutions will be prepared. This will lay the foundation for the electronic House Resolution system. This enabler projects an increase in the effective monitoring of house resolution from 64 in 2020/21 to 70 in 2021/22; 100 in 2022/23 and 130 in the outer year.

### Administrative support to MPLs

Business continuity and disaster recovery plans were implemented but the Legislature lacks the "how" portion. The Legislature has frameworks and policy imperatives in place, however, documented SOPs are still at draft phase. SOPs inform employees of the manner in which the operations have to be adequately conducted. This is evident by the outcome of the AG's audit report whereby the root cause of findings was cited as "inadequate internal control".

For the 2021/2022 financial year SOPs will be prepared for each division, commencing with Programme 3 – Legislature Operations as those divisions are core. SOPs will be created for both manual and ICT operations, i.e. virtual oversights and public participation programmes.

The ICT Steering Committee will continue addressing ICT related problems in an effort to move the Legislature into the 4IR (4<sup>th</sup> Industrial Revolution). For the 2021/22 financial year, the institution intends to implement the e-Parliament system.

With the implementation of the e-Parliament system, the institution will improve administrative support to MPLs to enable them to carry out their constitutional obligations.

### Oracle System stabilization - Phase II

The lowering of Lockdown restrictions to alert level 01 will enable implementation of the project to be fast tracked and concluded without extension of time with costs. Moreover, structured certified training

will be rolled-out through the Oracle University to ensure enhancement and optimization of the use of modules in their areas of responsibility.

#### **Political Parties Fund**

In a historic development for transparency and accountability in South Africa, President Cyril Ramaphosa has determined that the Political Party Funding Act will come into operation on 1 April 2021

President Ramaphosa signed a Proclamation on the Commencement of the Political Party Funding Act, 2018 (Act no. 6 of 2018), which regulates public and private funding of political parties. The Act establishes funds to provide political parties represented in Parliament and legislatures with funding to undertake their work. It also requires that donations be disclosed by parties and donors to the Independent Electoral Commission (IEC).

The Act prohibits donations to parties by foreign governments or agencies, foreign persons or entities, organs of state or state-owned enterprises. Parties may however receive funding from foreign entities for training, skills development or policy development. No member of a political party may receive a donation other than for political party purposes.

The implementation of the Political Party Funding Act will have far-reaching consequences for good governance and ethical political activity. It will strengthen the confidence of citizens in the democratic political process and enable them to assert their right to information.

#### 4. Reprioritisation

The Legislature has reprioritised the implementation of the Chamber wherein a bulk of the budget has been redirected to fund provincial fiscal pressures relating to provincial economic recovery plan and augmentation of the provincial COVID-19 funding. An amount of R77.4 million has been reduced from the 2021/22 baseline. An amount of R6 million has been redirected from goods and services to machinery and equipment with a plan to enhance the ICT infrastructure and tools of trade.

#### Compliance with COVID-19 regulations

An amount of R2.5 million; R2million and R1.5 million has been set aside for COVID-19 related procurement. The funds are intended to ensure that the Legislature building remains compliant with the COVID-19 regulations whereby sanitisation stations are maintained at designated areas, personal protective equipment (PPE) is provided to staff and MPLs, the building is decontaminated upon discovery of an infection and regularly in accordance with validity of the decontamination certificates. The appointed COVID-19 compliance Committee will continue to monitor adherence to regulations and ensuring that the building remain compliant.

#### 5. Procurement

The North West Provincial Legislature will procure goods and services (including consultants) efficiently, fairly and in a cost-effective manner using a transparent process. Procurement plans for procurements exceeding R500 000 and the demand management plan for procurement below R500 000 will continue to be implemented for the 2021/22 financial year, to ensure that the needs of the organisation are met. The NWPL aims to reduce the turnaround time for procuring goods and services. Internal controls, contract management and inventory management will continue to be strengthened.

The North West Provincial Legislature will also intensify its efforts to ensure that suppliers and service providers are paid within 30 days, in line with Financial Management of Parliament and Legislature Act, all quotations and bids will be awarded in a manner which is fair, equitable, transparent, competitive and cost effective.

In relation to procurement, in the 2021/22 financial year, the North West Provincial Legislature intends to:

- Fully implement the Oracle operating system for processing of orders and contract management for operational contracts;
- Continue to train and develop its staff;
- Acquire goods and services in line with targets, as indicated in the procurement plan;
- Ensure significant improvement in contract administration to ensure that the commitments are valid, complete and accurate;

The North West Provincial Legislature's activities are mainly funded through equitable share.

The main source of revenue for the North West Provincial Legislature is generated from interest earned from bank balances and commissions from third party payments. For the period under review, revenue remains stable due to the nature of the Legislature business.

FMPPLA provides for Provincial Legislatures to retain any monies received (i.e. revenue collected). Therefore, in contrast to provincial departments, the Legislature retains its own departmental receipts, and is thus funded from two sources, namely Provincial Treasury funding (equitable share) and departmental receipts.

#### 7. Payment Summary

# 7.1 Key assumptions

The NWPL applied the following broad assumptions when compiling the budget:

- All inflation related increases are based on CPI projections;
- Provision is made for wage increases over the MTEF in line with Provincial Treasury inflation guidelines; It should be noted however that the Legislative sector wage adjustment is not determined by the DPSA.
- NWPL will over the 2021 MTEF, adhere to the sectoral cost-cutting measures that will be issued in accordance with the Treasury's extensive cost containment measures;
- Payments of existing contractual obligations;
- Transfers to Political Parties will be done in line with inflationary projections;
- The COVID-19 pandemic will continue in the forseeable future, thus putting restrictions on travelling and public gatherings
- The North West Provincial Legislature will as far as possibly try to adhere to the cost cutting
  measures proposed by the Provincial Executive Council even though the Legislature is a separate
  arm of the state and is not bound by its decisions.

The budget allocation for 2021/22 increases steadily from R452.1 in the 2020/21 adjustment budget to R467.2 million in 2021/22; R487.5 million in 2022/23 and R490.5 million in the main.

**Programme 1: Administration:** The programme's budget increases from R230.9 million in the 2020/21 adjustment budget period to R245.6 million 2021/22 financial year and R250.3 million and R247.9 million respectively in the two outer periods. Funds have been reprioritised in an effort to contribute to government's efforts to stabilize fiscal spending in the foreseeable future.

The COVID-19 pandemic was declared a national state of disaster and NWPL made R10 million funding available to assist in terms of the Provincial Disaster Relief Fund.

**Programme 2: Statutory Payments:** The reduction in Members' salaries over the MTEF is motivated by government's effort to stabilise the spiraling public sector wage bill. The finance minister has to that effect announced that National Treasury will propose a three-year wage freeze. The salary freeze was motivated by the high salary bill which was deemed to be unsustainable. As a result, statutory payments decreases from R43.3 million in the 2020/21 financial year adjustment period to R35.1 million in the 2021/22 financial year .The programme experiences a slight increase of R35.4 million and R37.1 million in the two outer years.

Payments for MPL's salaries are statutory and thus form a direct charge against the Provincial Revenue Fund.

**Programme 3: Legislature Operations:** The budget for the core programme is informed by the facilitation of law making; encouraging public participation; and conducting oversight over the executive and statutory payments to political parties. The measures necessary to minimise the effects of COVID-19 resulted in limited activities of this programme.

The budget increases from R177.9 million in the 2020/21 financial year adjustment period to R184.6 million in the 2021/22 financial year. The amount further increases to R199.9 million and R203.6 million in the two outer years Expenditure in this programme is expected to be affected by restrictions on travel and gatherings as a result of COVID-19 in the 2020/21 financial year. These restrictions are expected to be eased in the two outer years as the population reaches herd immunity.

Compensation of Employees decreases from R242.1 in the 2020/21 adjustment period to R236.7 million in the 2021/22 financial year and R238.4 million and R241.0 million in the 2022/23 and 2023/24 financial years respectively. The reduction of salaries in the MTEF is motivated by government's effort to stabilise the spiraling public sector wage bill. Compensation of employees will also be used for annual salary adjustment, performance awards, salary progression and other COE related items.

The Goods and Services increase is driven mainly by the implementation of GRAP, ORACLE support, hire of high-volume printers, hiring of legal services, gardening services and rental for NCOP offices in Cape Town. The North West Provincial Legislature has also undertaken to reduce its reliance on consultants and travel agencies as a cost cutting measure. Goods and Services decreases from R144.7 million in the 2020/21 adjustment period to R138.1 million in the 2021/22 financial year. This decrease is mostly attributable to restrictions on travel and gatherings that are expected to continue in the 2021/22 financial year. The increase in the two outer years is as a result of the relaxation of COVID-19 restrictions as more than two thirds of the population is expected to be inoculated by the middle of 2022.

Transfers and Subsidies is mainly for political parties and increases by 5.36 per cent in the first year of the MTEF period and 4.8 per cent in the two outer periods of the MTEF respectively. Transfers to

political parties comprise of constituency allowance, secretarial allowance, research allowance and political party funding that enable members to fulfil their constitutional obligations and thus reducing dependency on private funding and enhancing multi-party democracy.

Payment for Capital Assets consists of Buildings and Other fixed structures, Machinery and Equipment as well as Software and other Intangible assets.

## 7.4 Infrastructure payments

## 7.4.1 Departmental infrastructure payments

The infrastructure allocation increases from R25.6 million in the 2021/22 financial year, R30.9 million in the 2022/23 financial year and R 32.1 million in the 2023/24 financial year The amount budgeted for is for Refurbishment of Chamber as well as National Key Point both of which are expected to be completed by the end of the MTEF period (see Table B5). The refurbishment of the chamber is not expected to commence in the 2021/22 financial year due to COVID-19.

# 7.4.2 Maintenance (Table B5)

The North West Provincial Legislature continues to implement maintenance of the Legislature building through the appointed service provider. The allocation for increases steadily from R7.4 million in 2021/22 to R7.8 million and the declines to R7.7 million respectively in the two outer years.

The North West Provincial Legislature transfers funds to political parties according to the number of seats that a party holds in the Legislature. Section 236 of the Constitution promotes multi-party democracy and in particular requires national legislation to provide for the funding of political parties participating in provincial legislatures on an equitable and proportional basis. Transfers to political

parties comprise of constituency allowance political party funding, research allowance as well as secretarial allowance

The allocations to political parties are managed through a Party-Political funding policy which outlines the factors that are considered when funding is calculated e.g. the number of Politicians per Researcher, the secretariat services for the various parties etc. The main objective of these transfers is to reduce reliance on private funding and to enhance multi-party democracy. Parties are entitled to a monthly allowance for each MPL to run a constituency office, and each political party makes its own constituency arrangements. Most constituency offices employ an administrator to be available to the public even when Parliament is in session.

The recipients of these transfers in the 2021/22 financial year are: African National Congress, Economic Freedom Front, Democratic Alliance and the Freedom Front Plus. Transfers to political parties grow at an inflationary projection over the MTEF.

### 8. Receipts and retentions: Provincial legislatures

According to Section 23(1) of the Financial Management of Parliament and Provincial Legislature Act 2009 (Act 10 of 2009), read in conjunction with Section 22(1) of the Public Finance Management (Act 01 of 1999), it is not obligatory for North West Provincial Legislature to surrender unspent funds to the Revenue Fund. This also applies to the revenue collected through interest earned from bank balances and commissions from third parties. However, the Provincial Legislature must approve the funds before being utilised.

## 9.1 Description and objectives

Purpose: To enable the administration to render support services that will enable Members of the Provincial Legislature and employees to fulfil their constitutional obligations.

### 9.2 Office of the Speaker

This office provides political and administrative leadership to the North West Provincial Legislature and ensures the provision of protocol services to Members. The bulk of the budgeted funds are for Compensation of employees for support staff in the office of the Speaker and Deputy Speaker, Travel and Subsistence for the Hon. Speaker and Hon Deputy Speaker as well as support staff. Some of the projects normally hosted by the Office of the Speaker, like "Basadi Re Aga Setshaba", Reconciliation Healing and Renewal are scheduled to be hosted virtually due to the fact that the COVID-19 pandemic is expected to continue in the forseeable future.

### Office of the Secretary

This office provides sound business support system towards supporting business objectives of the North West Provincial Legislature. The sub programme further coordinates planning, performance monitoring, evaluation and reporting, and ensures effectiveness of Risk management and governance processes. The North West Provincial Legislature management also resolved to centralize all advertising and printing budget to the Office of the Secretary. The decrease in the sub programme allocation is as a result of budget cuts introduced by National Treasury.

### **Financial Management**

Financial Management provides efficient and effective financial management, and includes the CFO's office, Supply Chain Management, Financial Management and Infrastructure and maintenance budget. The sub programme is responsible for ensuring continuous implementation of all relevant financial legislation and policies. The sub programme further hosts payment of management fees for two contracts, the consultancy fees for GRAP support and implementation; procurement of machinery and equipment; payment of the institution's mobile and landline bills; as well as the infrastructure construction, refurbishment and maintenance budgets. In addition, various costs relating to the Vote as a whole are centralised under this sub-programme, such as cell-phone, land-line and all current maintenance costs.

# **Corporate Services**

Corporate Services provides sound corporate resource system in support of the business objectives of the North West Provincial Legislature, through human resource and ICT. This unit exists to render a comprehensive, integrated human resource and administration function to enhance service delivery and the welfare of all employees. The budget for COVID-19 personal protective equipment is allocated under this sub programme. Training NWPL staff is budgeted for under this sub programme. The budget for this sub programme decreases in line with budget cuts announced by National Treasury and the reprioritization of funds from goods and services to compensation of employees. The budget for COVID-19 is budgeted for in this sub programme.

#### **Internal Audit**

The function of the internal audit unit is to provide independent, objective assurance and consulting services designed to add value and improve the Legislatures operations. The sub programme helps the NWPL accomplish the set objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, controls and governance processes. The budgeted funds are for compensation of employees, operational costs of this unit as well as Audit Committee Members Claims.

## **Sub programme descriptions: Logistics (Members)**

To provide benefits and facilities to Members and to offer support to political parties. This sub programme makes provision for the constituency and secretarial allowances, research allowances as well as the Political Party Fund.

The budget allocated in this sub programme is for Members travel and subsistence as well as constituency fees, including research allowances, secretarial allowance and Political Party Funding. These amounts are political mandates informed by the Members Enabling Facilities policy as well as the Party-Political funding policy. The Constitutional Court deemed the Political Funding Act of 2010, which was previously used to fund political parties, unconstitutional. Legislatures have therefore been

advised to draft internal policies that will be used in paying Political Party Funds. The North West Provincial Legislature has as a result drafted a policy in line with the court judgement. The sub programme increases steadily over the MTEF in line with inflation projections.

### Sub programme descriptions: Exposure to Parliamentary Services

To provide effective and efficient Members exposure programmes by producing a number of reports on MPL's training and participation events.

This sub programme is responsible for training and registration fees for members as well as to enable members of the North West Provincial Legislature to benchmark with other Legislatures domestically and internationally e.g. study trips, CWP etc. These exposure activities are integral in ensuring that the NWPL adopts best practices in the world. Travelling is expected to be severely restricted during the course of this pandemic, with most interactions expected to be virtual and or hybrid.

### **Sub programme descriptions: House Proceedings**

To provide administrative, procedural, secretarial, Hansard and language Services support to the House, Committees and NCOP by ensuring that a number of reports are tabled in the house and Hansard booklets are produced. Most house sittings are expected to be either virtual or hybrid due to the pandemic.

This sub programme is divided into two units, namely: Executive Manager: Legislature Operations and Proceedings. The budgeted amount includes among others, funding for production of Hansard Services as well as travel and subsistence for the Executive Manager: Legislature Operations.

#### **Sub programme descriptions: Committee Services**

To provide administrative, procedural, secretarial support to Portfolio Committees to enhance law making, oversight and public participation processes by ensuring that a number of committee reports are prepared for tabling in the House.

The budgeted amount is to enable members to exercise their constitutional mandate of doing oversight as well as to conduct public hearings when new bills are passed. The budget for this sub programme increases steadily over the MTEF period.

### Sub programme descriptions: National Council of Provinces Liaison Support

To facilitate effective liaison between NCOP and the Legislature and to improve support on law making processes and by producing a number of reports thereof.

The NCOP amount budgeted for under this sub programme is mainly for office rental for NCOP staff in Cape Town as well as travel and subsistence and compensation of employees that relates to the programme specific officials.

## Sub programme descriptions: Public Participation

To facilitate public participation in the law making and oversight processes by producing a number of reports on public participation and sectoral events organized. The sub programme is also responsible for other important events like Opening of Parliament and public education programmes. The current restrictions on travel and public gatherings are expected to have an impact on the number of people who can physically attend sectoral parliaments. The budget for catering and travel and subsistence has therefore been reduced in line with this expectation.

### Sub programme descriptions: Library, Research & Information

To provide reactive research services to Portfolio Committees in support of law making, oversight and public participation processes by producing a number of reports on research activities conducted. The sub programme is divided into Research Services and Library Services. The travel and subsistence allocation is anticipated to increase in support of strengthening the research activities by also augmenting the research staff.

The table above reflects personnel numbers and costs per component. Compensation of employees above also includes a Direct Charge for 22 members of the Legislature. The North West Provincial Legislature is at the moment in the process of implementing its organisational structure. This process was prompted by the fact that the institution is currently experiencing some skills gaps concerning the achievement of its objectives in terms of its constitutional mandate.

## 10.2 Training

The training costs increased steadily over the seven-year period in line with the organisation's skills development plan. Training for both Members and Staff is budgeted for under Legislature Operations and Administration Programme, respectively. The organisation also provides bursaries for qualifying Staff.

The North West Provincial Legislature continues to build capacity and improve the efficiency and effectiveness of staff members by encouraging participation in skills development programmes, management development programmes and bursary opportunities. The bursaries awarded in the 2021/22 financial year increased owing to the improvement in the bursary application and approval process.

The budget for training is centralised in Programme Administration under Corporate Services for better coordination and management.
