1. Overview

1.1 Vision

A prosperous Free State through facilitation of sustainable built infrastructure.

1.2 Mission

Coordination, provision, promotion of built infrastructure and sound management of assets.

1.3 Core function and responsibilities

- Public Works and Infrastructure, maintenance and construction as well as property management including the provision of office accommodation, utility and rental payments and provisioning of security services;
- Coordination and monitoring of the implementation of Expanded Public Works Programmes.

Main services

The Department of Public Works and Infrastructure remains the implementing agent for client Departments regarding construction and maintenance of provincial infrastructure.

Activities and events relevant to budget decisions

The Free State Provincial Growth and Development Strategy is still used as the key guide to achieve growth and development through further enhancement of National Youth Service Programme, Contractor Development Strategy, Broad Based Black Economic Empowerment and development of Small, Medium and Micro Enterprises. The infrastructure budgets of all client Departments are shown at the relevant Departmental votes and therefore their budgets and projects are not included in the further discussion of this Department's budget.

Aligning departmental budgets to achieve government's prescribed outcomes

Public Works and Infrastructure's budget has been aligned to enhance linkage with the governments seven priorities derived from National Government as well as provincial priorities.

2. Review of the current financial year (2023/24)

2.1 Maintenance

A total budget of R14.250 million has been allocated for scheduled maintenance and minor maintenance projects.

• Maintenance of lifts:

MOWA is the service provider appointed to service the lifts in three regions. Fidel Castro's lifts were modified in the 2022/23 financial. The contract for the lifts will expire on the 30 November 2023. and SCM is currently busy with the procurement of the new service provider.

• Sprinkler project:

The service provider has been appointed and busy with the assessment of the scope provided.

• Bethlehem offices damage due to storm: Awaiting the procurement and delivery of the material for the roof as per list provided to SCM.

2.2 Infrastructure Projects

• The Department of Labour did issue a prohibition notice for the Medfontein Building's closure. The Department is in the process to refurbish and repair all the defects to address all the OHS issues.

- A heritage architect was appointed for the restoration of the Free State House that was damage in a fire, the 4th Raadzaal and the Adelaide Hall at OR Tambo building to the total value of R108 million.
- Solar projects, the current plan is to install 15 solar systems in different office buildings, MPL houses and Prestige houses.
- The Thusanong project is envisaged to be completed in the 2023/24 financial year, however,
- the final payment and retention will be paid in the 2024/25 financial year.
- The first phase of Tshireletsong has been completed and the second phase of the project is at 90% and will be completed in 2023/24 financial year.

2.3 Information Technology

The high exchange rate impacted negatively on IT related expenditure in the current financial year. This caused an increase of R2 million in the annual renewal of the Microsoft license and a significant price increase in desktops, laptops, and network equipment. The department did also roll out Wi-Fi installation in the OR Tambo building, Salga House and Hamilton building. The department upgraded VOIP telephone infrastructure WAN routers and LAN switches including all remote offices and will be implementing VOIP at Bethlehem offices.

2.5 Internal Audit

The Department's Internal Audit unit is currently undergoing an external Quality Assurance Review as required by the International Professional Practices Framework for Internal Audit.

2.5 Rentals, municipal services, rates & taxes

The rental budget for properties addresses current lease contracts, however, there is an estimated shortfall of R81.673 million for Bophelo House in the current financial year.

The increase implemented by municipalities on municipal services, especially electricity, is also much higher than the growth of the Department's budget and this had a snowball effect over the last 10 years. The Department verified ownership of 4 891 properties on the asset register of the Department. The Department projects a shortfall of R1.055 billion on municipal services and R243.833 million for rates and taxes based on the devolved list and physical verification of properties. The general escalation of property services, water and electricity tariff is estimated at 15 percent.

The Department implemented a shared water savings project to reduce water consumption by calibration of meters, water pressure management, leak detection and maintaining water infrastructure. The project was implemented at seven hospitals within the province that realized a saving of R147 million over the period of five years.

2.6 Inflation and other related costs

The Department is contractually bound to pay escalation in rental contracts and increases on municipal services by municipalities. However, with the high increases in electricity and rental amounts, the Department cannot afford the full basket of services and will therefore not be able to meet its future financial and contracted obligations.

2.7 Expanded Public Works Programme

The Expanded Public Works Programme (EPWP) as one of Government's medium to long term strategies to reduce unemployment and alleviate poverty through the creation of work opportunities using labour-intensive methods will continue to receive attention from the Executive Council to

reduce unemployment scourge in the province. The Objective of EPWP Phase IV covering 2019/20 – 2023/24 is: "To provide work opportunities and income support to poor and unemployed people through the delivery of public and community assets and services, thereby contributing to development".

The Programme consists of the following Sub-Programmes:

- Community Development Sub Programme.
- Innovation and Empowerment Sub Programme.
- Coordination and Compliance Monitoring Sub Programme. Several Community Development initiatives such as Cash for Waste, Community Work Programme, Cleaning and Greening Programme and National Youth Service Programme are key towards income and livelihoods support for vulnerable communities through job creation.

The EPWP chief directorate is allocated R5.8 million towards Beneficiary Empowerment initiatives. This programme has seen expansion to all municipalities in Xhariep District as well as Setsoto local municipality. Implementation was guided by the executive authority priorities through budget injunctions for 2023/24 financial year. This budget had since been adjusted to R9.2 million and an additional R5.3 million rollover has been approved by Provincial Treasury to accommodate current learnerships until end of the financial year.

3. Outlook for the coming financial year (2024/25)

3.1 New policy priorities

The Department of Public Works and Infrastructure will continue to focus on the following National, Provincial and Departmental priorities:

- Promoting economic growth and development through national youth programme as well as infrastructure programmes.
- Accelerating delivery of infrastructure through fast tracking projects in an attempt to save on the total cost of delivery.
- Coordination and massification of EPWP in the province amongst all Departments and spheres
 of Government. The EPWP will be implementing phase 5 in the new financial year. Emphasis will
 be on youth development programmes as well as Massification orientated programme on
 infrastructure. There will be a need to secure projects for placement of leaners upon completion
 of their theoretical phase of training. The programme will also be expected to facilitate exit
 opportunities in line with phase 5 recommended strategies.
- Support and active utilization of National Youth Services programme.

3.2 Challenges

Information Technology

- Information and Communication Technology (ICT) experience challenges with upgrading the ICT Network and infrastructure in all the offices.
- Ineffective procurement processes at SITA make implementation of ICT projects very slow. The Department should have monthly meetings with SITA Provincial Office to ventilate these challenges.

Property Management

• Tariff increases for municipal services and leased property contracts in making provision for additional needs of client departments.

- The Department projects that the shortfall for municipal services and rates & taxes will increase due to accruals from the previous financial year, new properties identified and updated municipal valuation rolls.
- Custodian Asset Management plan is submitted annually to Provincial Treasury for Budget purpose, but still no additional funds were received from Provincial Treasury.
- No electronic system for the hosting of the Immovable Asset register as it is still on an Excel Spread Sheet.
- The process of implementing new contracts for expired leases is lengthily and the property market is unpredictable.
- Long disposal and acquisition processes that hampers Performance and Revenue enhancement.

Security Management

- The budget for private security will increase due to strengthen safety in relation to staff, assets and abundant sites. There is also a need to replace and procure two-way radios and base stations to improvement of communication.
- The Department will implement the maintenance contract to maintain the electronic security systems installed at the prestige residences and two office buildings.

3.3 Personnel

Skilled, healthy, ethical, diverse, and competent staff geared towards the achievement of departmental outcomes and the provision and effective management of provincial government land and buildings is key. The Department has not leveraged on its immoveable asset portfolio sufficiently for the economic development of the Free State Province, who has due to inter alia the depressed economic outlook and unacceptable high unemployment rate. During the 3rd quarter of the 2023/24 financial year the Free State Province has 70 000 more unemployed people than the same period twelve months ago. During the 2023/24 financial year the Department planned 40 appointments however this target will not be achieved due to the cost containment measures introduced nationally.

Furthermore, the availability of real time data and computing power is key whilst security protocols have become more sophisticated. Data coupled with key and new skills currently not on the staff establishment can contribute to creating alignment between the Department, financiers necessary for PPP and the citizens of the Free State who are the beneficiaries of infrastructure development. The energy crisis requires the department to explore and initiate green technology across its existing property and future infrastructure in a cost-effective manner.

The department will during the period under review align its skills development initiatives with the National Skills Development Plan, 2030, which highlights various desired outcomes inclusive of the following:

- Increase access to programmes leading to intermediate and high-level learning;
- Increase access to occupationally directed programmes in needed areas and thereby expand the availability of intermediate level skills;
- Increase access to high level occupationally directed programmes in needed areas; and
- Research, development, and innovation in human capital for a growing knowledge economy.

The workplace skills plan for the 2023/24 financial year will cater for key skills requirements of the various occupations on the establishment of the Department of Public Works and Infrastructure with emphasis on Property Management, Construction, OHS, Continued Professional Development, DPSA Compulsory Training and other work-related generic and line management interventions to address skills gaps of staff. Part time bursaries have also been awarded in accordance with developmental requirements geared towards increasing the NQF levels of staff.

During the 2023/24 financial year the Department will conclude the interventions identified during a skills audit of the Supply Chain Management environment. The skills interventions for the Supply Chain Management component have been concluded. These interventions directly address competency requirements. Furthermore, the Department will embark upon an intervention to up-skill and professionalise the staff within the works inspector occupation. Said intervention will enable them to register as professionals within in the discipline of professional building inspector as provided for by the SA Council for the Construction Project Management Professions. The Department have undertaken a skills audit of the Works Inspector occupation, and the skills intervention will be implemented during the financial year 2024/2025.

For the 2024/2025 financial year the Department will also include the undermentioned approved compulsory training programmes in terms of the Directive on Compulsory Training Programmes as approved by the Minister for the Public Service and Administration in terms of Section 41(3) of the Public Service Act, 1994 as amended.

- Compulsory Induction Programme (salary levels 1-14)
- Executive Induction Programme (salary levels 15-16)
- Compulsory Induction Programme (salary levels 1 14);
- Executive Induction Programme (salary levels 15 16);
- ✤ Khaedu training and deployment to service delivery sites (salary levels 13 16);
- Ethics in the Public Service (salary levels 1 –16);
- ✤ Managing of Performance in the Public Service (salary levels 6 12);
- Supply Chain Management for the Public Service (salary levels 9 16);
- Financial Management Delegations of Authority (salary levels 9 16);
- Re-orientation in the Public Service (salary levels 1 16);
- Basic Project Management for the Public Service (salary levels 6-12); and
- Advanced Project Management for the Public Service (salary levels 6-12)

The aforementioned, shall form part of the workplace skills plan for the 2024/25 financial year and beyond.

3.4 Rates & taxes, municipal services and landlords

The Department will pay R580.600 million on rates & taxes as earmarked in the allocation letter of the Department. The Department will pay R329.136 million on municipal services as per the centralized budget for the province as reflected within the Department of Public Works and Infrastructure's allocation. An amount of R354.922 million will be paid towards landlords for lease office accommodation. The shared water saving project will be extended to other hospitals, office buildings and testing facilities within the province.

3.5 Information and Communication Technology

Information Technology

The Department will be implementing an E-leave solution (R2.200 million) and E-Trip solution R0.425 million) based on the availability of funds. There is also a need for a Synchronised Security Solution which includes (Endpoint, Synchronised and Encryption) with an estimated licence fee of R2.200 million per annum.

The Department is in the process of upgrading the Information and Communication Technology networks in the regional offices, upgrade old hardware and to implement software solutions to support the mandate of the Department. The expansion of WIFI at Fidel Castro, Qwaqwa and Kroonstad building will supplement the existing network infrastructure.

Communication and Media Liaison

Effective government communication requires excellent coordination and integration of messages, campaigns, and programmes. It also requires the effective implementation of the Department's Communication Strategy. Therefore, priority is placed on crafting and implementing a development-communication approach that is responsive, relies on feedback, is creative and innovative and is about continuity and sustainability. A key outcome of this is consistent facilitation of and participation in Citizen Fora.

3.6 Grant and earmarked allocations

The Department received an allocation of R4.204 million as EPWP Integrated Grant to Provinces. An Infrastructure Enhancement Allocation (Equitable Share earmarked for Infrastructure) of R54.309 million was received which will be utilized towards infrastructure. Inclusive in this allocation is R12 million earmarked for maintenance and R15 million for the restoration of the Free State House. Property Rates and Taxes Enhancement Allocation of R580.600 million will be utilized for the payment of rates and taxes.

4. Reprioritisation

The Department has reprioritised non-core items to fund the needs of the core priorities within the Department.

5. Procurement

The Department's procurement plan is in line with the Supply Chain Management prescripts and legislation inclusive of Construction Procurement as outlined in the IDMS.

Planned major procurement

- Department of Public Works and Infrastructure has four (4) Inventory Warehouses that are operational. There are two (2) warehouses in Bloemfontein, one (1) for cleaning material and one (1) for Maintenance (Works) material. Two other warehouses are in QwaQwa, one (1) for cleaning material and one (1) for maintenance (Works) material.
- Project for establishment of SCM for Welkom (and Kroonstad) is delayed due to security risk on the identified site. The Security Directorate is busy compiling a security report.

Initiatives to improve Supply Chain Management

The following initiatives are being implemented to improve Supply Chain Management:

- Implementation and monitoring of the Treasury Regulations, Circulars, Instruction Notes, the Departmental SCM policies and delegations of authorities.
- The Bid Committees are sitting regularly to ensure that tenders are finalised and appointments to ensure service delivery objectives of the Department are achieved.
- SCM together with Works, and Maintenance Chief Directorate are in the process of going out on tender for the supply and delivery of building material framework contract. This will reduce the delivery turn around time for building material and improve efficiency on with the system.
- SCM will be finalising framework contracts for rendering of security services, and contractors on CIDB grade 3 to 6.
- Work together with all key stakeholder to ensure that contracts and service level agreements (SLA's) are signed timeously.

- Utilisation of suppliers on the Central Supplier Database and Free State Supplier Management System.
- Application of the CIDB register of contractors for infrastructure related projects.
- SCM officials attended an in house IDMS training in the current financial year.
- The skills interventions for the Supply Chain Management component have been concluded. These interventions directly address competency requirements.
