## **BILL**

**To provide for the appropriation of money from the Provincial Revenue Fund for the requirements of the province in the 2025/26 financial year; to prescribe conditions for spending funds withdrawn for the 2026/27 financial year before the commencement of the Limpopo Appropriation Act for the 2026/27 financial year; and to provide for matters incidental thereto.**

## **PREAMBLE**

**WHEREAS** section 226(2) of the Constitution of the Republic of South Africa, 1996 provides that money may be withdrawn from the Provincial Revenue Fund only in terms of an appropriation by a provincial Act or as a direct charge against the Provincial Revenue Fund, when it is provided for in the Constitution of the Republic of South Africa, 1996 or a provincial Act;

**AND WHEREAS** section 26 of the Public Finance Management Act, 1999 (Act No. 1 of 1999) provides, amongst others, that the Provincial Legislature must appropriate money for each financial year for the requirements of the province;

**BE IT THEREFORE ENACTED** by the Limpopo Provincial Legislature, as follows: —

### **1. Definitions**

In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Public Finance Management Act, 1999 (Act No.1 of 1999), has the meaning assigned to it in that Act, and—

**“conditional allocation”** means a conditional allocation to the province or municipality from the national government’s share of revenue raised nationally, which is provided for and whose purpose is specified in the Division of Revenue Act for the 2025/26 financial year envisaged in section 214(1)(c) of the Constitution of the Republic of South Africa, 1996;

**“current payments”** means any payment made by a provincial department classified as or deemed to be a current payment in accordance with the guidelines and instructions on economic reporting formats issued by National Treasury in terms of the Public Finance Management Act, 1999 (Act No.1 of 1999);

**“MEC”** means the member of the Executive Council responsible for finance matters in the province;

**“payments for capital assets”** means any payment made by a provincial department classified as or deemed to be a payment for capital assets in accordance with the guidelines and instructions on economic reporting formats issued in by National Treasury in terms of the Public Finance Management Act, 1999 (Act No.1 of 1999);

**“Payments for financial assets”** means any payment made by a provincial department classified as or deemed to be a payment for financial assets in accordance with the guidelines and instructions on economic reporting formats issued in by National Treasury in terms of the Public Finance Management Act, 1999 (Act No.1 of 1999);

**“Public Finance Management Act, 1999”** means the Public Finance Management Act, 1999 (Act No.1 of 1999); and

**“transfers and subsidies”** means any payment made by a provincial department classified as or deemed to be a transfer or subsidy payment in accordance with the guidelines and instructions on economic reporting formats issued in by National Treasury in terms of the Public Finance Management Act, 1999 (Act No.1 of 1999).

**2. Appropriation of money**

- (1) Appropriations of money by the Provincial Legislature from the Provincial Revenue Fund for the requirements of the province in the 2025/26 financial year, to votes and main divisions within a vote, and for specific listed purposes, are set out in the Schedule.
- (2) The spending of appropriations contemplated in subsection (1) is subject to the Public Finance Management Act, 1999 and the Division of Revenue Act for the 2025/26 financial year.
- (3) The spending of funds withdrawn from the Provincial Revenue Fund before this Act takes effect, as envisaged in section 29(1) of the Public Finance Management Act, 1999 is subject to the Limpopo Appropriation Act, 2024 (Act No. 2 of 2024).

**3. Amounts listed as specifically and exclusively appropriated**

An amount within a vote or main division within a vote that is listed as specifically and exclusively appropriated in the Schedule to this Act may be used only for the purpose indicated, unless the amount or purpose for which it was allocated, is amended by means of a Provincial Act.

#### **4. Conditions for appropriations**

- (1) The MEC may, in writing —
  - (a) impose conditions on an appropriation listed in the Schedule to this Act, other than a conditional allocation, in order to promote and enforce transparency and accountability and the effective management of the appropriation; and
  - (b) stop the use of an appropriation in respect of which conditions have been imposed in terms of paragraph (a), until such conditions are met.
- (2) The stoppage of an appropriation in terms of subsection (1)(b) must be disclosed in the Provincial Treasury's next quarterly report to the relevant Portfolio Committee.

#### **5. Authorisation of expenditure**

- (1) Despite any provision in any other legislation to the contrary and before an Adjustments Appropriation Bill is passed, the MEC may approve expenditure, if it cannot reasonably be delayed without negatively affecting service delivery and such expenditure —
  - (a) is unforeseeable and unavoidable;
  - (b) was announced during the tabling of the 2025/26 provincial annual budget for a project and the disbursement of funds is required for the implementation of the project; or
  - (c) was approved in the appropriation for the 2024/25 financial year and will be proposed to be rolled over to the 2025/26 financial year to finalise expenditure that could not take place in the 2024/25 financial year as originally planned.
- (2) Expenditure approved in terms of —
  - (a) subsection (1) may not exceed the total amount set aside as a contingency reserve for the financial year in the provincial annual budget;

- (b) subsection (1)(b) may not exceed the amount announced by the MEC for a specific item during the tabling of the provincial annual budget or adjustments budget.

- (3) Expenditure approved in terms of subsection (1) —
  - (a) is a direct charge against the Provincial Revenue Fund;
  - (b) may be made subject to conditions imposed by the MEC;
  - (c) must be disclosed in the Provincial Treasury's next quarterly report to the relevant Portfolio Committee; and
  - (d) must be included in the Adjustments Appropriation Bill or another appropriation bill for the 2025/26 financial year.

## **6. Spending before commencement of Appropriation Act for 2026/27 financial year**

The spending of funds withdrawn in terms of section 29 of the Public Finance Management Act, 1999 for the 2025/26 financial year before the commencement of the Appropriation Act for the 2026/27 financial year is, with necessary changes, subject to—

- (a) any applicable conditions imposed in terms of section 4 of this Act and the applicable provisions of the Adjustments Appropriation Act for the 2025/26 financial year, as if the funds were allocated for the 2025/26 financial year;
- (b) the applicable provisions of the Division of Revenue Act for the 2025/26 financial year, as if the funds were allocated for the 2025/26 financial year; and
- (c) the applicable provisions of the Division of Revenue Act for the 2026/27 financial year, when the said Act takes effect.

## **7. Short Title**

This Act is the Limpopo Appropriation Act, 2025.

## **WETSONTWERP**

**Om voorsiening te maak vir die bewilliging van geld uit die Provinciale Inkomstefonds vir die behoeftes van die provinsie in die 2025/26 finansiële jaar; om voorwaardes voor te skryf vir die besteding van fondse wat onttrek is vir die 2026/27 finansiële jaar voor die aanvang van die Limpopo Begrotingswet vir die 2026/27 finansiële jaar; en om voorsiening te maak vir aangeleenthede wat daarmee verband hou.**

## **AANHEF**

**AANGESIEN** artikel 226(2) van die Grondwet van die Republiek van Suid-Afrika, 1996 voorsiening maak dat geld uit die Provinciale Inkomstefonds onttrek mag word slegs in terme van `n bewilliging deur `n provinsiale Wet of as `n direkte koste teenoor die Provinciale Inkomstefonds, indien daarvoor voorsiening gemaak word in die Grondwet of `n provinsiale Wet;

**EN AANGESIEN** artikel 26 van die Openbare Finansiële Bestuurswet, 1999 (Wet Nr. 1 van 1999) voorsiening maak dat die Provinciale Wetgewer geld moet bewillig vir elke finansiële jaar vir die behoeftes van die provinsie;

**WORD DAAR BEPAAL** deur die Limpopo Provinciale Wetgewer soos volg:-

### **1. Omskrywings**

In hierdie Wet, tensy uit die samehang anders blyk het enige woord of uitdrukking waaraan `n betekenis geheg is in die Openbare Finansiële Bestuurswet, 1999 (Wet Nr.1 van 1999), sodanige betekenis geheg aan dit in daardie Wet; en—

**“voorwaardelike toekenning”** beteken `n toekenning aan die provinsie of munisipaliteit vanaf die nasionale regering se aandeel van inkomste wat nasionaal ingesamel was, soos uiteengesit in artikel 214(1)(c) van die Grondwet van die Republiek van Suid-Afrika, 1996;

**“huidige betalings”** beteken enige betaling gemaak deur `n provinsiale departement wat geklassifiseer is of beskou word as `n huidige betaling in terme van die instruksies uitgerek in die *Guidelines for Implementing the Economic Reporting Format* (September 2009), ingevolge artikel 76 van die Openbare Finansiële Bestuurswet, 1999;

**“LUR”** beteken die Lid van die Uitvoerende Raad verantwoordelik vir finansies in die provinsie;

**“betalings vir kapitale bates”** beteken enige betaling gemaak deur `n provinsiale departement wat geklassifiseer of beskou word as `n betaling vir kapitale bates in terme van die instruksies uitgerek in die *Guidelines for Implementing the Economic Reporting Format* (September 2009), ingevolge artikel 76 van die Openbare Finansiële Bestuurswet, 1999;

**“Betalings vir finansiële bates”** beteken enige betaling gemaak deur `n provinsiale departement wat geklassifiseer of beskou word as `n betaling vir finansiële bates in terme van die instruksies uitgerek in die *Guidelines for Implementing the Economic Reporting Format* (September 2009), ingevolge artikel 76 van die Openbare Finansiële Bestuurswet, 1999;

**“Openbare Finansiële Bestuurswet, 1999”** beteken die Openbare Finansiële Bestuurswet, 1999 (Wet Nr.1 van 1999); en

**“oorplasings en subsidies”** beteken enige betaling gemaak deur `n provinsiale departement wat geklassifiseer of beskou word as `n oorplasing of subsidie betaling in terme van die instruksies uitgereik in die *Guidelines for Implementing the Economic Reporting Format* (September 2009), ingevolge artikel 76 van die Openbare Finansiële Bestuurswet, 1999.

## **2. Bewilliging van geld**

- (1) Aanwending van geld deur die Provinciale Wetgewer vanaf die Provinciale Inkomstefonds vir die behoeftes van die provinsie in die 2025/26 finansiële jaar, aan begrotingsposte en hoofindelings binne `n begrotingspos, en gelys vir spesifieke doeleindes, word in die Skedule uiteengesit.
- (2) Die besteding of aanwending soos uiteengesit in subartikel (1) is onderhewig aan die Openbare Finansiële Bestuurswet, 1999 en die Wet op die Verdeling van Inkomste vir die 2025/26 finansiële jaar.
- (3) Die besteding van fondse onttrek vanuit die Provinciale Inkomstefonds voordat hierdie Wet inwerking tree, soos beoog in artikel 29(1) van die Openbare Finansiële Bestuurswet, 1999 is onderhewig aan die Limpopo Begrotingswet, 2024.

## **3. Bewilliging gelys as spesifieke en uitsluitlik**

'n Bedrag binne `n begrotingspos of hoofindelings binne `n begrotingspos wat gelys word as spesifieke en uitsluitlike bewilliging in die Skedule van hierdie Wet, mag slegs aangewend word vir die beoogde doel, tensy die bedrag of doel waarvoor dit toegeken was, gewysig word deur `n Provinciale Wet.

#### **4. Voorwaardes vir toekennings**

- (1) Die LUR mag, skriftelik —
- (a) voorwaardes oplê op toekennings in die bewilliging soos gelys in die Skedule van hierdie Wet, anders as 'n voorwaardelike toekenning, ten einde deursigtigheid te bevorder en af te dwing en vir effektiewe bestuur in verband met inkomste, uitgawes, bates en laste van provinsiale departemente en provinsiale openbare entiteite soos vereis deur artikel 18(1)(c) van die Openbare Finansiële Bestuurswet, 1999; en
  - (b) staak die toewysing van 'n toelaag waarop voorwaardes ingestel was ingevolge paragraaf (a), totdat sodanige voorwaardes opgelê word.
- (2) Die staking van 'n toewysing ingevolge subartikel (1)(b) moet openbaar gemaak word in die Provinsiale Tesourie se volgende kwartaallikse verslag aan die relevante Portefeuiljekomitees.

#### **5. Magtiging van Uitgawes**

- (1) Ondanks enige bepaling in enige ander wetgewing intendeel en voor 'n Begrotingswysigingswetsontwerp goedgekeur word, mag die LUR uitgawes goedkeur, indien dit nie redelik vertraag kan word nie en sonder dat dienslewering negatief geraak word nie, en sodanige uitgawes—
- (a) is onvoorsienbaar en onvoorkombaar;
  - (b) aangekondig was tydens die tertafellegging van die 2025/26 provinsiale jaarlikse begroting vir 'n projek en die uitbetaling van fondse soos vereis vir die implementering van die projek; of
