## 1. Overview

#### 1.1 Vision

A prosperous Free State through facilitation of sustainable built infrastructure.

#### 1.2 Mission

Coordination, provision, promotion of built infrastructure and sound management of assets.

#### **1.3 Main services and core functions**

- Public Works and Infrastructure, maintenance and construction as well as property management including the provision of office accommodation and security services, and the payment of municipal services and rentals; and
- Coordination and monitoring of the implementation of Expanded Public Works Programmes.

#### **1.4 Demands and changes in services**

There were no changes in services.

#### 1.5 Acts, rules and regulations

#### 1.6 Budget decisions

The Free State Provincial Growth and Development Strategy is still used as the key guide to achieve growth and development through further enhancement of the National Youth Service Programme, Broad Based Black Economic Empowerment and development of Small, Medium and Micro Enterprises. The infrastructure budgets of all client Departments are shown at the relevant Departmental votes and therefore their budgets and projects are not included in the further discussion of this Department's budget.

#### 1.7 Aligning departmental budgets to achieve government's prescribed outcomes

Public Works and Infrastructure's budget will be aligned to enhance linkage with the 7<sup>th</sup> Administration's three Medium-Term Development Plan (MTDP) priorities which is also the implementation plan of the National Development Plan (NDP).

# 2. Review of the current financial year (2024/25)

The Office of the MEC as the Executive Authority is mandated to play an oversight role in order to ensure that the Department achieve its strategic mandates. The mandate empowered the MEC to oversee all the strategic goals set by the Department holistically. The MEC managed to establish necessary mechanisms such as a War-Room, and project oversight visits towards ensuring that the strategic targets are achieved and within budget. The MEC further strengthened the Departmental collaboration with all relevant stakeholders, i.e. Landlords, Consultants and Contractors through establishing platforms for best practice sharing and provision of feedback.

#### 2.1 Maintenance

The total adjusted budget of R21.285 million has been allocated for scheduled maintenance and minor maintenance projects. A service provider was appointed on a three-year contract to service the lifts in three regions. Some of the budget is also intended to accommodate failures and maintenance requirements due to the ageing of the infrastructure and emergency maintenance in our buildings.

#### 2.2 Infrastructure Projects

The Department of Labour issued a prohibition notice for Medfontein Building. The Department is refurbishing the building and repairing all the defects to address the Occupational Health and Safety (OHS) concerns.

A heritage architect was appointed to restore Free State House that was damaged in a fire, 4<sup>th</sup> Raadzaal and Adelaide Tambo Hall at OR Tambo House to the total value of R108 million.

The Department installed solar systems at various office buildings, MPL and Prestige Houses.

The Thusanong office upgrade project is progressing slower than expected. It is envisaged that the project will be completed in the 2025/26 financial year.

The first and second phase of Tshireletsong has been completed, and the building was handed over to Social Development on 12 March 2025.

#### 2.3 Information Technology

The Department upgraded the Hamilton data line to fibre and replaced the old WAN router. A VoIP telephone system was implemented at the Bethlehem office.

#### 2.4 Internal Audit

The Department's Internal Audit unit is required to conform to the New Global Internal Audit Standards which has a major emphasis on IT auditing as an aspect of focus.

#### 2.5 Rentals, municipal services and rates & taxes

The rental budget for properties addresses the current lease contracts, however, there is an estimated shortfall of R95.741 million for Bophelo House in the current financial year. This amount is outstanding from the previous financial years and Transnet has requested to initiate the Intergovernmental Relations process.

The increase implemented by municipalities on municipal services, especially electricity, is also much higher than the growth of the Department's budget and this had a snowball effect over the last 10 years. The Department verified ownership of 4 889 properties on the asset register of the Department. The Department projects a shortfall of R847.346 million on municipal services and R142.013 million for rates and taxes based on the devolved list and physical verification of properties. The general escalation of property services, water and electricity tariffs is estimated at 9.5 percent.

#### 2.6 Inflation and other related costs

The Department is contractually bound to pay escalation in rental contracts and increases on municipal services by municipalities. However, with the high increases in electricity and rental amounts, the Department will have a shortfall on the municipal accounts.

#### 2.7 Expanded Public Works Programme

The Expanded Public Works Programme (EPWP), as one of Government's medium to long term strategies to reduce unemployment and alleviate poverty through the creation of work opportunities using labour-intensive methods, will continue to receive attention from the Executive Council to reduce the unemployment scourge in the province.

The Provincial EPWP Programme is coordinated by this Department. Phase 5 was launched both nationally and provincially during the 2024/25 financial year. This Programme responds to two of our Country's triple challenges namely unemployment and poverty and responds directly to Strategic Priority 1: Inclusive growth and job creation.

The Provincial MTEF target is to create 103 411 job opportunities for Departments and Municipalities during the 2025/26 and 2027/28 financial year, thereby contributing to the 5 million, 5-year national target. We will continue to implement and optimise Public Employment Programmes, including the Presidential Employment Stimulus, the National Youth Service, and Expanded Public Works Programme, to prioritise work experience for young people.

# 3. Outlook for the coming financial year (2025/26)

#### 3.1 New policy priorities

The Department of Public Works and Infrastructure will continue to focus on the following National, Provincial and Departmental priorities:

- Promoting economic growth and development through the national youth programme as well as infrastructure programmes.
- Accelerating delivery of infrastructure through fast tracking projects to save on the total cost of delivery.
- Coordination and massification of EPWP in the province amongst all Departments and spheres of Government. As already mentioned, EPWP Phase 5 was launched both nationally and provincially and the emphasis will be on youth development programmes and the Artisan Development Programme to address the skills shortage that the province is experiencing.
- The Artisan Development Programme was launched on 11 October 2024 with a target of developing one thousand (1 000) Artisan Trainees at various categories of built environment skills ranging from entry level candidates, practical training, work placement and trade testing. According to the Department of Higher Education and Training, the country currently only produces 15 000 artisans and falls short of the target of 30 000 artisans needed each year to tackle its growing workforce demand. This Department intends to contribute to this call of developing artisans.

The scope of work will include maintenance of facilities with the aim of restoring its original outlook and extend the lifespan of the buildings while enhancing the capacity for provision of state-owned office accommodation. Most activities will be conducted utilising labour-intensive construction methods to maximise on job creation while adhering to project management principles of executing projects on time within an approved budget.

#### 3.2 Challenges

#### Information Technology

Information and Communication Technology (ICT) experience challenges with upgrading the ICT network and infrastructure in all the offices. The ineffective procurement processes at SITA contribute to the slow implementation of ICT projects.

#### Property Management

The allocated budget does not provide for high tariff increases for municipal services and additional requirements of client departments in terms of office accommodation. The Department projects that the shortfall for municipal services and rates & taxes will increase due to accruals from the previous financial year, new properties identified and updated municipal valuation rolls.

The Custodian Asset Management Plan is submitted annually to Provincial Treasury for Budget purposes, however no additional funds were received from Provincial Treasury.

There is no electronic system in place for infrastructure projects and property management. The Immovable Asset register is still on an Excel spreadsheet. The Department explored various Smart Asset Management solutions including benchmarking with other provinces.

The process of implementing new contracts for expired leases is lengthy and the property market is unpredictable.

The long disposal and acquisition processes hinder performance and revenue enhancement.

#### Construction and maintenance

A fire compliant lift needs to be installed at OR Tambo House, and one of the existing lifts at Fidel Castro Building needs to be upgraded to be fire compliant. The Department reprioritised funds during the adjustment budget process for this purpose. Furthermore, the Department needs to upgrade the existing fire protection systems and equipment at 4<sup>th</sup> Raadzaal, OR Tambo House and Fidel Castro Building. The estimated cost for all three buildings amounts to R239 million.

#### 3.3 Personnel

Skilled, healthy, ethical, diverse, and competent staff geared towards the achievement of departmental outcomes and the provision and effective management of provincial government land and buildings is key. The Department has not leveraged on its immoveable asset portfolio sufficiently for the economic development of the Free State Province, who has due to inter alia the depressed economic outlook and unacceptable high unemployment rate.

Furthermore, the availability of real time data and computing power is key whilst security protocols have become more sophisticated. Data coupled with key and new skills currently not on the staff establishment can contribute to creating alignment between the Department, financiers necessary for PPP and the citizens of the Free State who are the beneficiaries of infrastructure development.

To have a lower carbon footprint, the Department must explore green or renewable energy across its existing properties and future infrastructure in a cost-effective manner.

The Department requires Property Valuers (2), Town and Regional Planners (2), GIS Technologists (2), OHS Managers (3), a Green Energy Technologist (1), and Property Economists (2) to supplement the professional portfolio of the Department during the period under discussion.

The Department will align its skills development initiatives, structure, systems and processes with the Medium-Term Development Plan 2024-2029 of the 7<sup>th</sup> Administration that will contribute to development of a capable, ethical and developmental state.

The Department has undertaken a skills audit of the Works Inspector occupation. This skills intervention envisaged to prepare works inspectors' professional registration at the South African Council for the Project Management Professions which commences in the 2025 academic year, should be concluded during the 2025/26 financial year.

For the 2025/2026 financial year the Department will also include the undermentioned approved compulsory training programmes in terms of the Directive on Compulsory Training Programmes as approved by the Minister for the Public Service and Administration in terms of Section 41(3) of the Public Service Act, 1994 as amended. It will also form part of the workplace skills plan for the 2025/26 financial year and beyond.

- Executive Induction Programme (salary levels 15 16);
- Compulsory Induction Programme (salary levels 1 14);
- Executive Induction Programme (salary levels 15 16);
- Khaedu training and deployment to service delivery sites (salary levels 13 16);
- Ethics in the Public Service (salary levels 1 16);
- Managing of Performance in the Public Service (salary levels 6 12);
- Supply Chain Management for the Public Service (salary levels 9 16);
- Financial Management Delegations of Authority (salary levels 9 16);
- Re-orientation in the Public Service (salary levels 1 16);
- Basic Project Management for the Public Service (salary levels 6 12); and
- Advanced Project Management for the Public Service (salary levels 6 12).

#### 3.4 Rates & Rentals, municipal services and rates & taxes

The Department will pay R562.600 million rates & taxes as earmarked in the allocation letter of the Department. The Department will pay municipal services amounting to R496.284 million as per the centralized budget for the province as reflected within this Department's allocation. An amount of R368.927 million will be paid towards landlords for leased office accommodation.

#### 3.5 Information and Communication Technology

#### Information Technology

The Department is in the process of upgrading the Information and Communication Technology networks in the regional offices, upgrade old WAN routers and to implement software solutions to support the mandate of the Department. The expansion of WIFI at Fidel Castro Building, QwaQwa Office and upgrading of bandwidth for the Kroonstad and Welkom Offices will supplement the existing network infrastructure.

The Department is exploring various Smart Asset Management solutions that incorporates the Immovable Asset Register, Project Management and Works Maintenance.

There is also a need for a synchronised security solution which includes Endpoint, Firewall and Encryption with an estimated cost of R2 million during the 2025/26 financial year.

#### 3.6 Grant and earmarked allocations

The Department will receive an Infrastructure Enhancement Allocation (Equitable Share earmarked for Infrastructure) of R49.309 million. Inclusive in this allocation is R12 million earmarked for maintenance and R10 million for the restoration of the Free State House. Property Rates and Taxes Enhancement Allocation of R562.600 million will be utilized for the payment of rates and taxes.

The Department received an EPWP Integrated Grant for Provinces allocation of R4.232 million for the 2025/26 financial year.

## 4. Reprioritisation

The Department has and will continue to reprioritise non-core items to fund the needs of the core priorities within the Department.

# 5. Procurement

The Department's procurement plan is in line with the Supply Chain Management prescripts and legislation inclusive of Construction Procurement as outlined in the IDMS.

#### Inventory warehouses

The Department has four (4) inventory warehouses that are operational. There are two (2) warehouses in Bloemfontein, one (1) for cleaning material and one (1) for maintenance material. Two other warehouses are in QwaQwa, one (1) for cleaning material and one (1) for maintenance material.

The establishment of an inventory warehouse in Welkom is being implemented.

#### Initiatives to improve Supply Chain Management

The Department will advertise a framework contract for the supply and delivery of building material. This should reduce the delivery time for building materials and improve the implementation rate of projects.

#### Sub-programmes

#### Programme support:

Overall management and support of the programme.

#### Community Development:

This sub-programme aims to provide income support to poor people and communities through participatory public employment approaches by creating assets and services that can have transformative impact on socio economic development. The sub-programme is also responsible for the development and empowerment of impoverished communities. Promote and create decent work opportunities through the provision of accredited training and implementation of community development initiatives.

#### Innovation and empowerment:

This sub-programme creates an enabling environment for emerging enterprises and address skills shortage in the construction industry through development of emerging contractors and youth and ensuring that EPWP responds to government's priorities of creating decent jobs, enterprise development and increase artisan base. The sub-programme is responsible to oversee contractor empowerment, training and development including learnerships, and providing SMME support and development.

#### **Co-ordination and Compliance Monitoring:**

This sub-programme is responsible for coordination, monitoring EPWP implementation and the management of Incentive Grant Expenditure to all public bodies implementing EPWP in the province. This sub-programme is entrusted with the provincial management and coordination of all stakeholders towards the successful implementation of the EPWP targets within the province in relation to the creation of work opportunities. The projects/initiatives and budgets are controlled by the public bodies (provincial departments and municipalities).

#### Focus Areas/Priority Areas

- Creation of work opportunities through implementation of community development initiatives;
- Massification of the Expanded Public Works Programme;
- Intensifying National Youth Service Programme;
- Skills training initiatives;
- Coordination and monitoring of all initiatives for compliance with EPWP guidelines;
- Promotion of exit opportunities for National Youth Service.

#### 9.2 Service delivery measures

The Department is responsible for infrastructure development, whilst simultaneously a dedicated focus and attention is placed amongst others on maintenance and construction of Provincial Government buildings; property management, co-ordination, monitoring and implementation of the Expanded Public Works Programme (EPWP). The recruitment strategy in the Department considers core skills needed.
