PROVINCIAL REVENUE FUNDS AND PRIMARY BANKING DETAILS IN TERMS OF SECTION 22 OF THE PUBLIC FINANCE MANAGEMENT ACT (PFMA)

PURPOSE

The purpose of this circular is to provide accounting officers and chief financial officers of all national departments with the primary banking account details of each province to ensure that deposits into the Provincial Revenue Funds are paid into the correct bank accounts, in compliance with Section 22 of the Public Finance Management Act (Act no. 1 of 1999), as amended.

2. **GENERAL ARRANGEMENTS**

- 2.1 Intergovernmental Cash Coordination (IGCC) accounts of provinces:
 - The accounts held at the Corporation of Public Deposits (CPD) in the South African 2.1.1 Reserve Bank (SARB) for the purposes of the Equitable Share transfers to Provincial Revenue Funds are as follows:
