contract in line with all National Treasury and departmental procurement guidelines?

NATIONAL TREASURY

None of the companies listed, were awarded any contracts and/or tenders.

ASB

The Accounting Standards Board did not award any contracts and/or tenders to the companies

listed above.

CBDA

No tender was awarded by the Co-operative Banks Development Agency to the companies listed

above.

DBSA

- (b) DBSA only awarded contracts to Vox Telecommunications.
- (i) Services contracted were for Least Cost Routing.
- (ii) (aa) Contract awarded in December 2009 was for R7,025,899-42. Contract awarded in July 2014 was for R 2,437,983-43. The total value paid for both contracts was R9, 463,882-85.
- (bb) Contract awarded in December 2009 was initially for a period of 24 months and further extended for 21 months.

Contract awarded in July 2014 was for a period of 36 months.

- (iii) Contract awarded in December 2009 was approved by the Divisional Executive ICT which was initially for an amount of R931, 822-75, the subsequent variations were signed off by the Group Executive, in line with the DBSA Internal Policies and Procedures.
- Contract awarded in 2014 was approved by the Supply Chain Management Committee and the subsequent variations were approved by the Supply Chain Committee.

FAIS OMBUD

Inspection of the available databases from the various departaments with the organization has provided no evidence that any of the above mentioned entities have been contructed to provide any goods or services to the FAIS Ombud for the period 2009 to 2018

FIC

- (b) The Financial Intelligence Centre has during the period, 1 January 2009 up to 09 November 2018 awarded contracts to Vox Telecommunications.
- (i) The services were for the provision of "Open text fax server connector, license renewal and standard support" and the move of the system to the new offices.
- (aa) The value of the contracts for the award, installation, support and renewal of the support agreements for the Right Fax amounted to R249 276.96 and the cost of the move to the new building was R51 521.16.
- (bb) The period during which the contracts were awarded was from 2010 to 2015.

- (iii) The awards were approved in terms of the normal operational delegation of authority, effective at that stage.
- (iv) The awards followed normal procurement procedures and were fully compliant with National Treasury guidelines on procurement.

FSCA

- (b) Of the companies mentioned, the Financial Sector Conduct Authority (then the Financial Services Board) has only appointed Vox Telecommunications [Vox Telecommunications (Pty) Ltd (Registration Number: 2011/00077/07] through a public bidding processes.
 - i. For supply and installation of Audio Visual Equipment
 - ii. (aa) R564 106.18
- (bb) Once off procurement (during 2017/18).
 - iii. The Bid Adjudication Committee of the FSCA
 - iv. Yes, the tender met all the required public procurement prescripts.
- In addition, the FSCA during 2015/16 has awarded a bid (with respect to quotation, i.e. procurement below R500 000) to Vox Telecommunications amounting to R140 128.80 during the period under request. The quotation was approved by the Procurement Manager in terms of the applicable Delegations of Authority and it was a once off purchase as well for supply, installation, configuration and testing of SIP telephone handsets.

GEPF

The GEPF had a contract with Orion Telecom (now Vox Telecoms) prior to 2009 (in 2004) for the provision of telephone voice managed services. The subscription service covered Orion's three least cost routing services, being cellular, international and national calls.

The subscription service provided for monthly telephone usage recovered from the GEPF by Orion Telecom, the cost of which fluctuated depending on usage. The initial contract was for 18 months with a provision for renewal for further twenty-four month periods and continued rolling over periods of twenty-four months. The agreement is still in place for continuity of voice managed services.

The agreement was approved by the then Deputy Director-General at National Treasury responsible for GEPF. Based on the documentation available, the procurement policies in place were followed at the time.

GPAA

Vox Telecommunication Services is the only service provider to which Government Pensions Administration Agency awarded a contract.

(i) what service was provided:

Procurement of bandwidth data and extended warranty for 11 vehicles used as mobile vans for client outreach programs.

Mercedes Benz was appointed as the supplier/ service provider to provide customized vehicles (vans) to the GPAA for outreach programs. The subcontractor utilized by Mercedes Benz to customize the vehicles was Vox Telecommunication.

The Bid Adjudication Committee recommended the award to the accounting officer for approval and the procurement was reported to the National Treasury as a deviation, as prescribed at the time.

(iv) Was the tender and/or contract in line with all National Treasury and departmental procurement guidelines?

It was aligned to the deviation process prescribed by National Treasury.

These contracts were concluded. All contractual commitments have been met and the PO's have been depleted.

IRBA

The IRBA hereby declares that no contracts or tenders were awarded to the abovementioned companies.

LAND BANK

The Land Bank has not awarded any contracts and/or tenders to any of the listed companies from 1 January 2009 to date.

PFA

The Office of the Pension Funds Adjudicator has not awarded contracts and/or tenders to the companies listed above from 01 January 2009 to date.

PIC

The Public Investment Corporation (PIC) reviewed their records and accordingly; they have never allocated nor appointed any of the companies listed in Annexure A to do any work on Assets under Management and Corporate. They can however confirm that PIC was approached by Naledi Forge to acquire DCD Group. They received approval from the Portfolio Management Committee to proceed to Due Diligence, but the Sponsor never got back to them, with next steps.

SARS

SARS has viewed the vendor database and found that there were no tenders/contracts awarded to the above mentioned companies from 1 January 2009 to date.

SASRIA

Whilst we took care, and exercised the necessary diligence in preparing the requested information, it is pertinent that we highlight the fact that we completely relied on the stated service providers' company names as stated above. Therefore, in cases where the service provider's registered name differs with the trading name, there exists a slight possibility that the service provider may have not been picked up, depending on what had been recorded on our database at transaction stage.
