

## EXPLANATORY NOTE ON COVID-19 RELATED EXPENDITURE FOR NATIONAL AND PROVINCES

## FINANCIAL YEAR 2020/21

## **ISSUED BY THE DIRECTOR-GENERAL: NATIONAL TREASURY**

The Government of South Africa announced a R500 billion COVID-19 support package in 2020, the details of which was reported in the June 2020 Supplementary Budget. Direct budget allocations amounted to R142 billion in proposed spending, with the remainder provided through tax measures, a loan guarantee scheme and support provided through the Unemployment Insurance Fund.

This report provides information on direct budget support (R142 billion) provided by national and provincial departments. Spending is reported against the COVID-19 support package announced in the 2020 Supplementary Budget and adjusted in the 2021 2nd Adjustments Budget. Expenditure Information was extracted from the financial systems of government and will be updated as and when final departmental financial statements are published.

National and provincial departments spent R122.5 billion of the R142 billion allocated in the 2020 Supplementary Budget. Included in this expenditure is transfers of R59 billion that will be reported on in the financial reports of the relevant spending agencies.

Details of transfer payments are as follows:

- Support to vulnerable households: The Social Relief of Distress grants were paid as part of the existing grant management system by SASSA. The full budget was paid to SASSA by the DSD and details of spending will be provided in the financial statements of SASSA.
- Support to municipalities: The COVID-19 allocation was paid as part of the monthly transfers to local government. Spending by local government on COVID-19 interventions are reported in the Section 71 report for Local Government published on the National Treasury website.
- Basic and higher education: The R5 billion allocated to Higher Education Institutions was paid as part of higher education grants.
- Allocations to support public entities have been paid as part of entity transfers.
