

The Republic of South Africa has received funding from the African Development Bank toward the Municipal Financial Management Capacity Building Support, and intends to apply part of the agreed amount for this funds to payments under the contract for consultancy services for the analysis of municipal pension, retirement and provident fund schemes presently utilised across local government. The objective of this assignment is firstly, to verify the number of pension, retirement and provident fund schemes that presently support local government and then to establish their financial standing and legitimacy in terms of the local government legal framework. The assignment will be executed over a period of 126 working days (six months). .

Interested consultants must provide information indicating that they are qualified to perform the services including brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc. Consultants may constitute joint-ventures to enhance their chances of qualification.
